The upper age limit for applicant is 63 years as on last date of receipt of applications. The number of vacancies may be increased or decreased as per the requirement of DDA.

2. The relevant eligibility criteria are as under

- 1. Candidate must have passed Station Officer Course from NFSC, Nagpur / FSTI, Hyderabad or any other recognized institute having minimum 05 years post qualification experience in supervisory capacity.
- 2. Applicant must have retired from Central/ State Govt./ State PWD/ PSU/ Semi Govt. / Autonomous body/ nationalized banks with pay in Level-7 or equivalent at the time of retirement.
- 3. Retired officers from Police/State municipalities or PWD / Industrial security Force/ Public Sector undertaking/ Autonomous Bodies (Under Govt.) / Nationalized banks in the post Fire officer/Inspector/Manager (Fire) or equivalent possessing experience in administrative duties of fire cadre, firefighting, fire prevention fire training etc during the service in Supervisory capacity.

3. Method of Selection and terms & conditions

The terms & conditions including remuneration for engagement as consultant will be governed by as per policy's guidelines issued vide F&E/ DDA's Circular No. 23/2018 dated 05.12.2018.

The applications will be screened by Pre-Evaluation/ Consultancy Evaluation Committee in accordance with the policy guidelines vide Circular No. 23/2018 dated 05.12.2018. No correspondence in this regard will be entertained. Intimation shall be sent only to the short-

listed candidates for personal interaction through e-mail for which no TA/DA etc. will be payable.

4. Instructions for candidates

Only those candidates will be called for interactions who are found suitable as per the criteria devised by the DDA keeping in view the requirement of the work to be carried out. - iii. No TA/DA will be paid for attending the interaction.
- iv. The jobs description for the for the post of Fire Officer includes Fire safety inspections of DDA buildings, Live testing of fire fighting equipments installed in DDA buildings, Daily inspection of fire fighting equipments and fire control room located in Vikas Sadan, to liaison with Delhi fire service for quick action in case of emergency, routine inspections of office premises/sports complexes etc.
