ESTABLISHMENT ORDER

On the recommendations of Senior Level Review Departmental Promotion Committee (Group 'A' Officers), Vice-Chairman, DDA is pleased to promote Abhishek Kumar S/o Sh. Ram Darshan Singh Azad (UID- 7802526), Assistant Director (Architect) to the post of Deputy Director (Architect) notionally with reference to his junior Ms. Prashansa since promoted to the post of Dy. Director (Architect) vide E.O. No. 124 dated 06.03.2025 in Level -11 (Rs .67,700-2,08,700/-) of Pay Matrix as per 7th CPC [Prerevised in - the pay band of Rs .15600-39100/- with Grade Pay of Rs.6600/-) 6th CPC].

2. He will retain his seniority in the grade of Dy. Director (Architect) above his junior, namely, Ms. Prashansa (Sty. No. 84) since promoted to the post of Dy. Director (Architect) vide E.O. No. 124 dated 06.03.2025. However, he will be entitled for pay fixation in the promotional post with effect from the date of his actual promotion only and not entitled to any arrears of pay and allowances for the intervening period i.e. from the date of promotion of his junior i.e. 06.03.2025 to the actual date of promotion. The eligibility service in the promotional grade for further promotion shall also commence only from the date of his actual promotion

3. No financial benefits shall be allowed to above named officers, if he/she had already been granted benefit of financial upgradation under ACP/MACP Scheme in Level -11 (Rs. 67,700-2,08,700/-) of Pay Matrix as per 7th CPC [Pre-revised in the pay band of Rs .15600-39100/- with Grade Pay of Rs.6600/- (6th CPC)]. If not granted, his/ her pay will be fixed under the provisions of FR.22(I)(a)(1). He/ she may exercise his/ her option for fixation of pay under the provision of FR.22(I)(a)(1) within 30 days from the date of issue of this order.

4. Consequent upon the above promotion, the Competent Authority is pleased to post him in the Dwarka & West Zone, HUPW. He is directed to report to Concerned Officer with a copy to Dy. Director (P)-I. The promotion will be effective from the date of his joining to the post of Deputy Director (Arch.).

5. This promotion order is subject to the final outcome of the decision of Hon'ble Supreme Court of India in SLP (C) bearing No.026494/2019 titled Ashok Kumar Vs Kanwal Kumar and Ors. and SLP (C) No.001762/2020 titled Nidhi Tyagi Vs Kanwal Kumar and Ors.

6. This promotion is provisional and subject to outcome of pending Contempt Petition No. 314/2016 and SLP (C) No. 4831/2012 before Hon'ble Supreme Court.
