CIRCULAR

SUB: ISSUE OF 'IDENTITY CERTIFICATE' FOR OBTAINING PASSPORT.

In view of modifications in Section 6(2) of the Passports Act, 1967, the competent Authority had *vide* U.O. No. F.7(52)2006/PB-I/DDA/7063 dated 07.05.2007 (copy enclosed for ready reference), decided to invariably observe the following formalities before issue of 'No Objection Certificate' for obtaining passport:

- (i) to obtain Vigilance Clearance Report of the official, and
- (ii) to obtain undertaking on a non-judicial stamp paper in the enclosed *pro forma*.
- 2. The modifications in Section 6(2) of the Passports Act, 1967 also require issue of **'Identity Certificate'**, **in duplicate**, in the format prescribed by the Passport Office, along with attested photograph of the concerned official.
- 3. Accordingly, it has now been decided that the said 'Identity Certificate' may be issued, **under the signature of Deputy Director** of the concerned Personnel Branch, as per format prescribed by the Passport Office under Section 6(2) of the Passports Act, 1967, after obtaining the approval of the Competent Authority.
- 4. This issues with the approval of Commissioner (P).
