Sub.: Additions/alterations in the flats constructed/allotted by Delhi Development Authority.

Sir,

In continuation of this Ministry's letter of even number, dated 3.4.2001, approving a list of 19 condonable items in respect of additions/alterations made by the allottees of DDA flats, I am directed to state that in pursuance of the judgement of the Hon'ble High Court of Delhi, dated 27.9.2002 in CWP Nos. 2729/96 and 3482/2001, this Ministry had constituted a Review Committee, vide O.M. of even number, dated 25.11.2002, to have a fresh look on the recommendations of the Technical Experts Committee and to suggest feasibility of allowing more covered area in DDA flats.

2. The Review Committee, after taking into consideration the views of the Federation of Residents Welfare Association, Sarita Vihar, New Delhi, the petitioner in CWP No. 3482/2001 and the suggestions made by the Chairman, Apex Association of DDA Colonies for making additions/alterations in DDA flats has since submitted its report.

3. Keeping in view the structural safety considerations and the recommendations of the Review Committee, contained in its report dated 18.12.2002, the Government have decided **that the following items may be added to the list of 19 condonable items earlier approved** by this Ministry vide letter of even number, dated 3.4.2001:

- (i) Fixing doors in back or front courtyards.
- (ii) Converting window into Almirah subject to availability of light and ventilation.
- (iii) Shifting of water storage tank/raising of the parapet wall up to 5' high and putting additional water storage tank at the location specified subject to capacity of storage of water limited to 550 litres.
- (iv) Shifting of the front glazing doors/windows up to maximum outside up to existing chajja.

4. In addition to above, the following items could also be permitted by DDA/MCD on due submission of detailed drawings by the allottee duly certified by a qualified structural Engineer:-

- (i) Construction of bathroom and WC in the rear courtyard subject to the condition that the existing services are not affected.
- (ii) Covering of the open terrace with sloping roofs up to 9 ft. high with lightweight material such as fibre glass/AC sheets/GI sheets/pipes and standard angle iron sections, etc. and enclosing with glazing.
- (iii) Inter-change the position of Kitchen, Bathroom and WC with proper power connection, subject to structural safety.

5. In respect of Item 4 (iii), consent of all the affected occupants/allottees shall also have to be obtained by DDA/MCD prior to such sanction. DDA may lay down detail procedure to be followed for sanction of these items.
