A tender was called by DDA and as per the terms and conditions of NIT, all the bidders were required to submit a solvency certificate of an amount equal to 40% of the estimated cost of the work.

Whereas, M/s.Mi2C Security & Facilities Pvt.Ltd. also submitted its tender alongwith a solvency certificate issued by HDFC bank Ltd. However, on its verification with the bank it come to the knowledge that bank had not issued such solvency certificate submitted by M/s.Mi2C Security & Facilities. A SCN was issued to the M/s.Mi2C Security & Facilities Pvt.Ltd. for the same and after receipt of its reply, the issuance of solvency case was again sent to HDFC Bank for its confirmation. Again Bank denied for issuance of said solvency certificate. Therefore, the solvency certificate was fake & forged as submitted by the agency.

Whereas, department had decided to take an action against M/s.Mi2C Security & Facilities Pvt.Ltd. and has desired to know the possible actions for forfeiting the earnest money and to debar it from tendering in DDA.

Whereas, a legal opinion was also obtained by the EE/ND-8/DDA from legal cell and legal cell recommended for following action:

- 1) For forfeiture of EMD.
- 2) Debarring the agency.

Action for(1):-

EMD has been forfeited by EE/ND-9 on dt.09.08.2019.

Action for(2):-

Whereas, the case has been recommended by CE (R) for debarring the agency for tendering in DDA.

The case was put up before the board during its meeting 21.01.2020, the board after due deliberation and discussion has decided to debar the agency for two year from date of issue of this order.
