Sub: Transfer to Medical Card on death of Card Holder.

As a welfare measure VC, DDA has been pleased to approve following amended procedure for smooth & speedy reimbursements in case of death of Prime Card Holder.

- A. In case of death of Prime Card Holder, where **only deletion** entries are to be pursued by Medical Cell it will be made on the basis of death certificate. No reference/documentation from Pension Cell to be insisted (until & unless there **is addition in** the Card required).
- B. For such cases, DDA Medical Scheme will allow grace period of 3 months (both at the retirement i.e. for pensioner & also in case of death of prime card holder i.e. for family pensioner) & will allow followings:
 - i) Medical Advance in respect of alive dependents (as per Medical Card) are to be allowed even if card has not been transferred.
 - ii) IPD claims/reimbursements in respect of alive dependents (as per Medical Card) are to be allowed even if card has not been transferred.
