
With reference to Circular no. 05/2018 dated 03.04.2018 regarding re-imbursement of claims in respect of CKD cases, the matter has further been considered and it is noted that dialysis is stage 6 (last stage) of CKD. Accordingly the delegation approved vide Circular referred to above needs to be linked to stage 2 of CKD i.e. even without dialysis.

Accordingly, in terms of Authority's Resolution No. 208 dated 25.02.1967, Vice Chairman, DDA has been pleased to approve following further delegation relating to re-imbursement of claims of CKD.

Cases of medicines claims (without dialysis) may also be allowed/reimbursed under approved delegation subject to following documents submitted by Medical Beneficiaries:-

- i) Test report of CKD stage (reimbursement to be allowed from stage 2 onwards).
- ii) Initial/first approval will be with approval of CAO w.r.t. Govt. specialist prescription and test report. Thereafter every year prescription of DDA empanelled hospital specialist may be accepted by Medical Cell.


