1 Delhi and DDA Rich past with a promising future

Delhi, an ancient historical city of myths and legends, was once a barren piece of land developed by the Pandavas as their capital- Indraprastha. Centuries after centuries, Delhi witnessed the rise and fall of many empires and evolved into the global metropolis it is today. It's a city where the past and the present co-exist effortlessly, where resplendent monuments stand majestically alongside glitzy skyscrapers. Delhi was anointed the seat of power of numerous empires only to be razed by their adversaries time and again. Every time it rose from its ruins like a phoenix and emerged as one of the most prominent cities in India. Scores of forts and archaeological sites littered across the city stand testimony to the eras gone by which add to Delhi's inherent charm and its infinite attractions.

Starting from Qutab-ud-din to Khiljis and Tuglaqs to Mughals there was a succession of emperors and empires that added many dimensions to Delhi's history. Eventually in 1911, the city became the capital of British India. That became an indisputable facet of Delhi's character which continues till date as Delhi remains the celebrated capital of independent India. Initially a site near the Northern Ridge was proposed as the capital but was later changed to the location around Raisina Hills. But it was Edward Lutyens and Herbert Baker —renowned British town planners, who gave Delhi its unique character and grandeur as a metropolis when they drew the blueprint of New Delhi in 1912.



A tiny Nazul office, consisting of 10 to 12 officials, was set up in the Collectorate of Delhi in 1922 which was the first Authority to regulate the planned development of the city. In 1937, the Nazul office was upgraded to an Improvement Trust, constituted under the provisions of the United Provinces Improvement Act, 1911, to control building operations and regulate land usage. The year 1947 was a landmark year which changed the course of Indian history. With independence came separation, which resulted in a huge inflow of migrants to Delhi. The city's population shot up from 7 lakhs to 17 lakhs which led to critical shortage of urban infrastructure and virtual collapse of civic services. Migrants were forced to occupy vast open spaces. A new direction and planned development of the city was the need of the day.

The two local bodies at the time, Delhi Improvement Trust and Municipal Body, were not quite equipped to cope with the changing scenario. In 1950, the central government appointed a committee under the chairmanship of G. D. Birla to plan and check Delhi's rapid and haphazard growth. This committee recommended a single planning and controlling authority for all urban areas of Delhi. Consequently, the Delhi Development (Provisional) Authority (DDPA) was constituted by promulgating the Delhi (Control of Building Operations) Ordinance, 1955 (replaced by the Delhi Development Act, 1957) with the primary objective of ensuring the development of Delhi in accordance- with a plan. Thereafter, on 27th December, 1957, Delhi Development Authority acquired its present name and assumed its historic responsibility as the 9th builder of Delhi.

Delhi was a canvas which needed the sure and steady strokes of a skilled artist. DDA had a lot of challenges upfront which needed professional acumen and long sighted planning. Thereafter, it formulated the Master Plan for Delhi in 1962 with perspective up to 1982, for an organized and structured growth of the city. This Master Plan became the benchmark and blueprint for other cities to follow DDA's footsteps. The key features of this Master Plan envisaged identifying land that could be developed into residential areas and create self contained colonies by providing ample space and support infrastructure for commercial use as well. This Master Plan was extensively revised with perspective up to 2001 and was

adopted in 1990. It was further modified extensively keeping in mind vision and policy guidelines for perspective period up to 2021 and was notified on 7th February, 2007. The Master Plan is to be reviewed at five year intervals to adapt to the changing times and accordingly be modified.

DDA gradually transformed Delhi into a global metropolis, with its team of world class town planners. DDA pioneered several landmark initiatives that today serve as benchmarks in India's urban development. DDA also formulated zonal plans, action area plans and urban extension projects. The spheres covered include housing schemes, commercial complexes, office spaces, land development, transportation, infrastructure, recognition and preservation of heritage sites in Delhi, sports complexes, play grounds, golf courses, sustaining the environment, retaining green belts and forests, etc. DDA's visionary initiatives and efforts have led to Delhi being recognized as one of the greenest capitals of the world. DDA is credited for having developed 5,050 hectares of greens including 4 regional parks, 25 city forests, 111 district parks, 255 neighborhood parks, 15 sports complexes, 3 mini sports complexes, 2 golf courses and 26 play-fields.

DDA's constant endeavors to create Delhi as a millennium city are evident in the creation of verdant green belts with

the setting up of Delhi Biodiversity Foundation to nurture natural resources and greenery of the city for the future. The key objective of the Foundation is to retain the rich ecological and natural biodiversity of the National Capital Territory of Delhi. Four first-of-their-kind biodiversity parks are being developed by DDA with technical inputs by a team of scientists who have specialized in the areas of biology, ecology and wildlife. While creating Delhi's global persona, DDA has gone well beyond its mandate of urban infrastructure development to address problems related to transportation and daily commuting of the citizens. DDA has set up the Unified Traffic and Transport Infrastructure Planning and Engineering Centre (UTTIPEC) for planning roads, highways and related infrastructure to reduce congestion and enhance mobility of Delhi's burgeoning traffic. DDA has also modernized its logistics to introduce online services in order to facilitate better services, quicker turnaround time and transparent operations across services rendered to the public. Today Delhi has emerged as a dynamic, vibrant, global metropolitan city which is the culmination of DDA's initiatives and endeavors. A constantly evolving dynamic city keeping pace with the changing times while retaining its old charm and rich historical past.







During the year 2016-17 DDA introduced several measures for systemic improvement and also took up several new initiatives. Some of these are as follows:-

- 1 Modifications made in Delhi Building Byelaws, 2016.
- 2 Online approval of building permits in DDA development areas.
- 3 Preparation of seamless revenue base map for planning zones.
- 4 Preparation of comprehensive plan for Yamuna river front development project.
- 5 Continued development work of bio-diversity parks, namely, Aravali, Yamuna, Neela Hauz, Tilpat Valley and Tuglakabad bio-diversity parks.
- 6 Documentation for formulation of mandate of Unified Centre for Rejuvenation of River Yamuna (Restoration and Beautification) (UCRRY) and final notification of UCRRY.
- 7 53,950 dwelling units under construction in various zones with prefab technology, which includes over 51,000 LIG and EWS/Janta dwelling units.
- 8 Construction of 5 community halls was completed, 18 are in progress, 24 are at planning stage and 15 at the conceptual stage.

- 9 3 Commercial Centres/Complexes/District Centres constructed and 6 more are under construction.
- 10 Protection of the land in Yamuna flood plain with constant monitoring against encroachment.
- 11 An RFP is being drafted for selecting an agency to computerize all departments of DDA through its project titled "Digital Services.—Computerized Management System for Decision Support and Online Public Services (including Grievance Redressal) System (CMS)" to provide effective public services to customers and employees to usher in transparency in public dealing through online digital service delivery.
- 12 Online filling of measurement book by contractors and engineers of DDA have been continued and upto 31.3.2017, online measurements have been taken for 531 engineering projects.
- 13 DDA's website has been redesigned and updated with various online applications. All the contents of the website are also being translated in Hindi.
- 14 Software developed for DDA Awasiya Yojana, 2017 for submitting application details online by applicants and making payments through NEFT/RTGS/Net banking.
- 15 A web enabled software "Interactive Disposal of Land Management (IDLI)" developed for data capturing and retrieval of institutional properties.



Management of the Authority

3.1 Members of the Delhi Development Authority

Delhi Development Authority was constituted under Section-3 of the Delhi Development Act, 1957. It is a corporate body with the power to acquire, hold and dispose of property. Shri Najeeb Jung was the Lt. Governor of Delhi and Chairman, Delhi Development Authority from 09.07.2013 till 22.12.2016. Shri Anil Baijal, former Union Home Secretary, took over charge as the 21st Lt. Governor of Delhi on 31.12.2016. Shri Baijal has also held charges of Secretary (Urban Development), Government of India; Vice Chairman, DDA; Chief Secretary, Andaman & Nicobar Islands and CEO of Prasar Bharti amongst other assignments. Shri Baijal has also served on the Executive Councils of think tanks and multiple corporate boards apart from being an Advisor on National e-governance Advisory Group (NAG), Advisory Group for Integrated Development of Power, Coal and Renewable Energy and Committee on Implementation of Corporate Social Responsibility. 4.2 Architecture Department (HUPW)

The Architecture Department utilizes the Structural Land Use Plan of project scheme for preparing its conceptual architecture design and working drawings of architectural concept. The thrust areas for Architecture Department are:

- 1. Developing the Urban Design / Architectural Schemes (Housing of all categories, Hierarchical, Non Hierarchical Commercial Centers as per Master Plan for Delhi) and their development control norms.
- 2. Initiating and formulating heritage and conservation projects.
- 3. Sports related projects (Designing sports projects)
- 4. Social infrastructure projects (community facilities, upgradation plans, etc.)
- 5. Conduct and co-ordinate Screening Committee meetings for approval of all projects of planning, architecture and landscape departments.
- 6. Obtaining approvals from :
 - Delhi Urban Arts Commission for urban design / architecture schemes ;
 - Delhi Urban Heritage Foundation for all heritage/ conservation related projects;
 - Other authorities like Chief Fire Officer, Airports Authority of India, Environmental Clearances, Archaeological Survey of India, etc.

Since all architectural works are design related, each individual project is required to go through various stages of approval from local agencies as per codal provisions. DDA has also initiated various heritage related projects which are ongoing under the aegis of Delhi Urban Heritage Foundation. They are Global Landscape Design Competition for Urban Park "Bharat Vandana" Prangan, Historical Hardayal Municipal Public Library, Sunder Nursery, Mehrauli Archaeological Park, Sultan Garhi Archaeological Park, Aravali Biodiversity Park and St.James Church, Kashmere Gate.

4.3 Landscape and Environmental Planning Unit

Delhi, spread over an area of 1497 sq. km, is one of the greenest metros in the country. The city has experienced tremendous growth in recent times, with increased pressure on its open spaces. Delhi Development Authority has played a key role in the overall development and management of its green spaces, with conscious efforts towards development of open spaces as Regional parks, District parks, Green belts, Neighbourhood greens, etc. With approximately 3800 small and big parks under its jurisdiction, DDA has kept its commitment of upgradation and maintenance of green areas, which form the lungs of the city; with its recent efforts towards development of Bio-Diversity Parks, river front development, reclamation of sanitary landfill sites and rejuvenation of water bodies and revival of lakes.

DDA has promoted conservation of natural features like the river and the ridge, has developed green belts, theme parks, urban woodlands, green areas around monuments, bio-diversity parks, etc., which are being designed by the Landscape and Environmental Planning Unit of DDA. This encompasses-

Designing and policy decision related to Regional Parks as per norms laid down in the Master Plan.

Designing of all the District Parks under the jurisdiction of DDA, along with Neighborhood Parks, Playfields and Children Parks.

Special projects like Bio-diversity Parks, river front development, reclamation of sanitary landfill sites, heritage projects and green linkages have been taken up by the Unit. The concept of water harvesting and conservation of rainwater, recharging of groundwater aquifers is an integral part of planning of various greens. In the process of designing and up-gradation of green areas, efforts have been made to incorporate design features for differently abled people. These design features have been introduced in entrance plazas, kids play areas, sitting areas and pathways. For example, the entrance Plaza of Millennium Park provides ramps for ease of access to all people with special needs. The new wave of using eco-friendly concepts and material in DDA greens has materialized by installing bamboo shelters in Reserve Forests, Regional parks and Restricted Forests. Toilets have been proposed in the parks and playfields for the Swacch Bharat Abhiyaan. Open gyms were executed for better public health in parks and more open gyms have been proposed. Childrens' play equipment with fiber glass material are being installed for safety purpose.

Engineering and Construction Activities

5.1 Housing:-

During 2016-17 about 53,950 dwelling units were under construction in various zones with pre-fab technology. Details of houses in progress as on 01.04.2016 and new houses taken up for construction are as follows:-

5.3 Major Development Schemes of Land :-

DDA is continuing its process of development of land for expanding the city limits as per the Master Plan. The new subcities under development are Dwarka, Narela and Rohini. The main physical infrastructure facilities provided in these



sub-cities like roads, sewerage, drainage, water supply, power lines, etc., during the year are as follows:-

5.4 Community Halls

DDA has taken up construction of Community Halls in a big way. During 2016-2017, 05 Community Halls were completed, 18 are in progress, 24 are at planning stage and 15 are at the conceptual stage.

5.5 Commercial Shopping Centres/ Complexes.

During the year 3 Commercial Centres / Complexes / District Centres have been completed and 6 are under construction / in progress.

5.6 Socio Cultural Centres:

To meet the growing demand for social activities, creation of 2 Socio Cultural Centres have been proposed at CBD Shahdara and Mayur Vihar District Centre to be executed during year 2017-18. Accordingly RFP for selection of technical consultant for preparation of feasibility report has been invited.

5.7 Lighting of parks:-

DDA has completed the task of providing lights in 27 parks during the year.

5.8 In-situ Development:-

i) In-situ development at Jailerwala Bagh, Ashok Vihar, Delhi.

The construction of 1675 multi storied dwelling units for in-situ rehabilitation of slum dwellers at Jailerwala Bagh, Ashok Vihar has been taken up.

The layout and architecture plans were approved by the Screening Committee on 10.04.2015 and approval was issued on 16.06.2015. Other statutory clearances were received from DUAC, Delhi Fire Services and Environment clearances on 09.03.2016, 19.04.2016 and 29.04.2016 respectively.

Subsequently it was decided by DDA to revise the plans as per revised building byelaws. The agency was asked to revise the architectural and structural drawings accordingly. The modified drawings have been submitted to Architecture Wing for approval and the same approved in the Screening Committee meeting held on 16.11.2016 and issued on 29.12.2016. The structural drawings have also been received and are under proof checking at CBRI, Roorkee.

5.9 Urban Extension Roads

DDA has undertaken the construction of the following three Urban Extension Roads along with ROBs on Delhi Karnal Railway line and Delhi Rohtak Railway line. These roads are being constructed to decongest the traffic load, reduce pollution level, improve the connectivity to the main arterial roads and increase the pace of development of urban areas in Delhi.

The stretch wise details are as under:-

UERs have not been taken up in P-II zone due to non acquisition of land. UERs are being constructed only where land is available with end connectivity.

Status of UER-I

UER-I has been constructed from NH-I to Bawana Auchandi Road (9.43 km) except combined Road over Bridge (ROB) on Delhi Karnal railway line and FCI godowns at Narela. Northern Railways has started construction of ROB on their part of land. On decision from Ministry the tenders for balance part of ROB will be called. No further land has been acquired for construction of UER-I.

Status of UER-II

UER-II has been constructed from NH-I to Kanjhwala Road (12.35 km) except Road under Bridge at Holambi Kalan.

From Kanjhwala Road to NH-10 (5 km) there are unauthorized colonies, namely Bhagya Vihar and Mir Vihar under which a tunnel has been proposed.

Further, a stretch of 3 km from NH-10 to Bakkarwala is in advanced stage of construction and is likely to be functional in another three months.

Land is available for 3 km stretch from Bakkarwala to Nangloi - Najafgarh Road (Dichau Kalan depot) except in two unauthorized colonies of Dichau Enclave and Amar Colony. Geotechnical investigation has been completed and Preliminary Estimates are under preparation. From Dichau Kalan depot to Najafgarh (7 km), there are a number of unauthorized colonies such as Drain Nagli Sakrwati, Masoodabad, Shyam Vihar, Roshanpura, etc, which are densely populated. The construction of this stretch will be possible only after "relocation policy" and resettlement options are finalized for the affected population. However, boundary wall are being constructed to protect the available stretches of land in this stretch.

Land for road is available from Najafgarh drain to Rewari line underpass for which NIT is ready. The part from Rewari line to NH-8 near Shivmurti is constructed and functional. Land from NH-8 to NH-2 is yet to be acquired.

Status of UER-III

Urban Extension Road (80m Right of Way) has been constructed from Western Yamuna Canal to Majri Road (Sector 21 / 22, Rohini) for a length of 7.3 km. No further land is available for construction of UER -III.

There is an unacquired parcel of land near Prem Aadhar Nursery (Sector 24 / 32, Rohini) affecting 70 m of road. However, the road has been made fully functional by making diversion around unacquired land.

5.10 Bio-diversity parks:-

DDA has recently developed Aravali, Yamuna and Neela Hauz bio-diversity parks and recently taken up the work of Tilpath Valley bio-diversity park, near Maidan Garhi and Tughalakabad bio-diversity park.

Sanjay Van is a Reserve Forest over an area of 783.43 acres. DDA has recently planted species of medicinal plants in some area in Sanjay Van.

5.11. Maintenance of Water Bodies

DDA has recently revived some water bodies and work of revival of some water bodies is in progress.

5.12 Protection of Land in Yamuna Flood Plain:-

This is a big task which includes 45 km. stretch where National Green Tribunal (NGT) has decided that no construction activity shall be allowed. The land is well protected and properly fenced. The situation is constantly monitored by QRT.

5.13 Quick Response Teams (QRT)

Quick Response Teams (QRT) headed by Asstt. Engineers have been formed in all zonal Chief Engineer offices to monitor encroachments on DDA land and for clearance of unauthorized encroachment of DDA land.

5.14 Roads

All Master Plan and Sectoral roads under DDA are being properly maintained by DDA.

5.15 Miscellaneous Activities :

Up-Gradation and Maintenance of DDA Parks.

- (i) DDA has provided open gym equipment in some parks. About 20 gyms shall be provided during 2016-17 & 2017-2018 in South, Dwarka and West Zones.
- (ii). The work for construction of 71 new toilets on PPP mode has been awarded in various parks in Dwarka Zone and tender has been called for construction

of 52 toilets in various parks of South Zone. All these toilets will be made functional during the year 2017-18.

- (iii). The work of laying of pipe lines and construction of UGRs for supplying STP / CETP treated water in various parks in Mayapuri, Hari Nagar and Rajori Garden has been completed in 2016-2017.
- (iv). Jahanpanah City Forest : Jahapanhan City Forest is spread over 435 acres and being maintained as Reserve Forest.

(v). Development of Satpula Lake Complex.

Satpula Lake Complex is spread over 40 acres in South Delhi. This complex is surrounded by Press Enclave Road, Sheikh Sarai Facility Centre and Village Khirki. In order to improve the area, a landscape plan of the lake complex had been prepared. The development work has started recently and will be completed in three years.

(vi). Urban Park at Vasant Kunj.

RFP has been invited for appointment of consultant for designing an Urban Park at Vasant Kunj. The consultant shall submit the over all design of the park and the work shall be taken up in the next year.

(vii). Aastha Kunj adjoining Nehru Place District Centre:

DDA has developed 81 ha. greens named as "Aastha Kunj" in its District Park abutting Nehru Place, between the Bahai and ISCON temples.

(viii). Millennium Park

In order to beautify Delhi, the entire land between the railway line and Ring Road from ISBT Sarai Kale Khan to Bhairon Mandir Marg which at one time used to be a sanitary landfill site has been landscaped.

- a) Total length of park along Ring Road -----About 2 km.
- b) Total length of the walkways -----About 5 km.
- c) Total length of jogging track -----About 6 km.
- (ix). **Green Linkage:** DDA is working on green linkages in two phases.
- (a) **Phase-I**: It covers the parks of Gulabi Bagh, Hauz Khas, Ashok Vihar and Shalimar Bagh with present progress of 85%.
- (b) **Phase-II**: It covers the parks of Ashok Vihar, Shalimar Bagh and Pitampura with present progress of 5%.

Land Management and Land Disposal Departments

7.1 Land Management Department

7

Delhi Development Authority has vast area of land of different categories under its jurisdiction. Besides, looking after Nazul-I land, which came to DDA from the erstwhile Development Improvement Trust, it also manages and takes care of Nazu1-II land acquired by DDA after 1957. DDA has also some land, which was taken over from the erstwhile Ministry of Rehabilitation under a package deal. In addition, some land of Land & Development Office, Ministry of Urban Affairs is also with DDA for care and maintenance.

Main functions of the Land Management Department are:-

- i) Acquisition of land
- ii) Management of land
- iii) Assisting the land user departments
- iv) Coordination with various departments and outside agencies for land management matters.
- v) Planning and execution of demolition programmes for encroachment removal.
- vi) Action against unauthorized construction in Development Areas.

No land has been handed over by the respective Land Acquisition Collectors (LACs) of Delhi to DDA during the period under report.

The Damages Branch of Land Management is entrusted with the work of eviction and assessment and recovery of damages from unathorised occupants squatting on govt. land. There are two Estate Officers who have been delegated powers under the P.P.Act to discharge their duties of assessment of damages and eviction.

Systemic changes made to improve the functioning of the Land Management Department of DDA.

The following measures have been taken to improve the functioning of Land management Department of DDA:-

- **1.** Inventorization of vacant DDA plots.
- i) Earlier, there was no complete compilation of vacant plots of DDA. A comprehensive list of all vacant plos under the various land owning departments i.e.,

Land Management, Engineering, Horticulture has been prepared in excel sheet with complete details and uploaded on DDA website.

- Details include name of village, khasra number, area of plot, encroached area if any, actual vacant area of plot, area of built-up/ encroachment, land use, layout plan, contact details of supervisory officer, photos with latitude and longitude of site and litigation status.
- 2. Standard Operating Procedures (SOP) for land protection has been prepared and circulated for its implementation.
- i) Standard Operating Procedures (SOP) for protection of DDA land by concerned officers of the Engineering and Land Management Departments have been issued. These orders fix responsibility of officials from Kanoongo/ Jr. Engineer level upto the level of Dy. Director/ Ex. Engineer. The officer/ official responsible for inspecting lands under his jurisdiction has been uploaded on the excel sheet and the periodicity of inspecting these sites has been fixed in the SOP. Kanoongos/ Jr. Engineers are to inspect each property under their jurisdiction at least once a week and their reporting officer should inspect the sites once a month. The respective Dy. Directors/ Ex. Engineers are required to personally inspect at least 10% of the most vulnerable/valuable vacant plots under them every two months. Concerned Heads of Departments i.e., Chief Engineer, Commissioner (LM) and Director (Horticulture) shall submit monthly reports to Vice Chairman, DDA on work done by each officer/ official.
- ii) In case any encroachment is noticed, it shall be responsibility of the concerned Department to get the same removed. Thereafter land shall be handed over to Engineering Department with proper demarcation. After removal of encroachment, photographs shall be taken and uploaded on the website. The site shall be handed over to the Engineering Department both physically at site and through handing/ taking over on paper.

Prevention of encroachment would be the responsibility of the user department. Engineering Department will clear current encroachments through QRTs. Litigation status of sites would be provided by land management department. Code numbers would be assigned for each



plot alongwith land use. All large vacant plots of land would be handed over to Engineering Department alongwith proper demarcation. Smaller vacant plos would be disposed of immediately.

iii) Earlier, there was no standardized and comprehensive format being followed by the various land owning Departments of DDA for executing demolition programmes for removal of encroachments. A detailed standardized format has been prepared which is required to be filled in by the concerned officer of the Department while sending requisition for execution of demolition programmes.

3. Development of mobile phone based application for monitoring of encroachment on DDA land.

The field staff responsible for inspecting DDA lands as mentioned in SOP issued vide this office order dated 7/10/2015 have been provided android based mobile phones and application has been developed for uploading photographs of sites which will also indicate the longitude and latitude with date of photographs. The officer inspecting the site is also required to upload a selfie at site. All these photographs are required to be posted on the application.

4. Strengthening supervisory staff of Land Management Department.

The Enforcement Wing of Land Disposal and Housing Departments have been wound up and the work transferred to the Quick Response Teams (QRTs) of the zonal Chief Engineers.

5. Rotational transfer of field level officers.

All field level officers of Land Management Department including Patwaris, Kanoongos, Naib Tehsildars, Tehsildars, Asstt. Directors, Asstt.. Engineers, Jr. Engineers and Surveyors who had completed more than one year at their present place of posting have been transferred. All security guards in the Land Management Department who have been posted for long in the same zone have been transferred.

6. Transfer of vacant lands to Engineering Department.

It has been decided that all vacant lands lying with the Land Management department would be handed over to the Engineering Department after proper demarcation at site. Details of khasra numbers, longitude and latitude of sites, etc., would be clearly mentioned in the handing / taking over records. Apart from this, after the coordinates are demarcated at site, the handing / taking over shall be done between Land Management and Engineering Department. The handing over of plots to Engineering wing are under process.

8.1 Housing Activity has been taken up by Delhi Development Authority since 1967-68. From time to time, various schemes for allotment of flats under various categories has been launched. The first registration scheme was opened in the year 1969. Thereafter, 43 more schemes have been launched till date.

8.2 DDA Housing Scheme-2014

DDA launched the Housing Scheme-2014 on

01.09.2014 for allotment of about 25034 flats in different categories. Out of 11328 live cases Possession Letter in respect of 9023 cases have been issued and the remaining cases are in progress for completion of codal formalities.

8.3 Conversion of Flats

Total 3983 CD papers have been issued for conversion from lease hold to free hold under existing policy guidelines w.e.f. 01.04.2016 to 31.03.2017.





- **9.1.1 Complete computerization of DDA:-** An RFP is being drafted through a retired Director General of NIC for selecting a suitable agency / consortium through open tender to computerize all Departments of DDA through its project titled "Digital Services-Computerized Management System for Decision Support and Online Public Services (including Grievance Redressal) System (CMS)" to provide effective public services to its customers and employees and to usher in transparency in public dealing through online digital services delivery.
- 9.1.2 Design, development and implementation of mobile applications:-
- (a) Mobile application for online filling of Measurements Books of Engineering Projects:-In DDA, a user friendly mobile and web based application has been designed and developed for filling Measurement Books (MB) by the contractors and engineers online and during the process of filling the latitude and longitude of the location are also captured. This ensures that the engineer has actually visited the site for taking the measurements. This online filling of MB will help in completion of projects in time.

Upto 31st March, 2017 for 531 Engineering Projects, online measurements have been taken and more than 457 bills have been processed online for which payments have been made to contractors.

b) Mobile application for protection of land by uploading periodic photographs:- This mobile application has been designed and developed in DDA through which the officials of Land Protection Wing, Engineering and Horticulture Wings, upload photographs of vacant lands periodically. In this process, the latitude and longitude of the locations are also captured though these photographs and thus one can easily detect encroachments and timely action for removing them can be taken.

- c) Feedback applications regarding maintenance of Sports Complexes and Community Halls:-Applications for taking feedback from public about the maintenance of Sports Complexes and Community Halls of DDA have been designed and developed. Public gives the feedback through these mobile applications and this feedback is utilized in maintenance, supervision and in making payments to the contractors responsible for their maintenance.
- d) Mobile application for taking feedback for DDA flats from allottees:- This mobile application has been designed and developed for taking feedback from allottees of DDA flats about the quality of construction and maintenance services. The feedback can be captured based on various parameters and the maintenance services improved and payment of security deposit of contractors is also co-related with the feedback of the public.
- e) Monitoring services in DDA parks through Mobile Apps:- A mobile based and web enabled application has been designed and developed through which the services in DDA parks are being monitored through public feedback. Public can upload site photographs and DDA officials take action immediately and again upload the photographs after resolving the issue. Till date 181 feedbacks have been received from the public for various departments.

- **9.1.4 Online VIP References Monitoring System :-** To monitor the references received from various VIP's, online web enabled system has been developed and made operational on DDA's website.
- 9.1.5 Bio-metric based Attendance system:- Aadhar



based attendance machines have been procured and these will replace the existing attendance machines,

- **9.1.6 Re-vamping and updation of DDA's website:**-DDA's website has been re-designed and updated with various online applications for the staff and public in addition to the already available applications.
- **9.1.7** On line booking of DDA's parks, Community Halls and open spaces:- During the year 2016-17 thousands of bookings have been made online. The details are as under:-

- **9.1.8** Nagrik Suvidha Kendras and online lease hold to free hold conversion:- An application is operational at all the Nagrik Suvidha Kendras for receiving applications for conversion and these Nagrik Suvidha Kendras are further connected through computer network with the respective departments. This application is running on DDA's website, www.dda.org.in. With the provision of Nagrik Suvidha Kendras and this application, the rate of clearance of conversion applications has increased from 72% to 75% in 2016-17.
- **9.1.9 Online Samasya Nidhan Sewa:-** A web enabled online application known as Online Samasya Nidhan Sewa is operational on DDA's website to resolve the grievances of the public and to send replies to public online. During 2016-17 the details of grievances received and answered through this application are as under:

- **9.1.10 Online pension computerization:** An application for providing the services to pensioners for timely payment of dues and completing timely formalities of their retirement dues has been developed and made operational on DDA's website. During 2016-17, 1555 cases of pension have been processed with this system.
- **9.1.11 Online payment of water bills:-** A web based application has been implemented for receiving the

payments of water bills from public online. Data of 21169 consumers are available in this application and payment gateway of Union Bank is integrated with this application.

- **9.1.12** File tracking system:- A file tracking system is operational in all the departments of DDA which is a web enabled application. From 1.4.16 to 31.03.17, 41310 files have been uploaded on the system in different departments of DDA.
- **9.1.13 Medical Claims Reimbursement System:** A web enabled application for re-imbursement of medical claims for DDA employees and pensioners is operational on DDA's website. From 1.4.16 to 31.03.17, 31360 OPD and 7964 IPD claims have been processed through this application.
- **9.1.14 Provision of online payments for housing and land properties:-** In compliance with the directions of Govt. of India for digital /online payments, payment gateways of various banks, i.e. HDFC, Corporation Bank, Central Bank, Union Bank, Indusind Bank, Axis Bank, ICICI Bank, etc., have been integrated with DDA's website and public can make payments for housing and land properties online through RTGS, NEFT and net banking. Payments can also be made with debit and credit cards.
- **9.1.15** Scanning and digitization of files:- An ambitious work of scanning and digitization of files of various departments of DDA has been started in 2016, and till March, 2017 about 80,000 files (1.05 crore pages) have been scanned and digitized. This information will be most useful for court cases and will be a relief tool in case of misplacement of a physical file. It will help in answering RTI queries as well.
- **9.1.16** Online system for monitoring of complaints regarding encroachment on DDA land:- A web enabled application is operational on DDA's website for receiving complaints regarding encroachment on DDA land in the form of video, audio and text messages. About 2635 complaints have been registered in this system and action is being taken by concerned Chief Executives.
- **9.1.17** Online system for monitoring VIP, MPs & MLAs references:- Through this application action taken on the proposals and requests of MPs and MLAs of Delhi regarding various issues related to their constituencies is monitored online.
- **9.1.18** Online personnel grievances redressal and monitoring system:- An online web enabled application for monitoring the grievance redressal of DDA's employees is operational on DDA's website.
- 9.1.19 Online building plan sanction monitoring system:-A web enabled application has been developed for

receiving building plans online and sanctions are also provided online by the Building Section. The provision for receiving online payments for building plan sanction has also been made.

- **9.1.20** Building Plan Permit Monitoring System:- A web enabled software for tracking references sent to external agencies for seeking NOC for Building Plan Permits has been developed. Based on the details of project entered, the same is forwarded to external agencies for seeking NOC. Once NOC is received from a particular agency, date of receiving is entered and the details can be tracked online.
- **9.1.21 AWAAS & Housing allotments:** AWAAS online applicaton provided computerized allotment through draw process, issuing the Demand Letters as well as online verification of payments.
- **9.1.22** BHOOMI & Online Services for Rohini Residential Scheme, 1981:- An online application has been developed for online printing of demand letters by allottees and for viewing the payment details by the allottees for Rohini Residential Scheme,1981. Besides, allottees can make online payments through this application.
- **9.1.23** Vigilance Complaints Management System:- A web enabled software for monitoring vigilance complaints at various levels has been developed. Once the details of Vigilance complaints are entered, action can be taken by the concerned officer of Vigilance Department and online tracking can also be made.
- **9.1.24** A software for monitoring system for allotment of land to Govt. / Semi Govt. agencies has been developed for entering application details by the applicants online. All the application details submitted by the applicants are available to the concerned departments for processing these cases.
- **9.1.25** A mobile app for **feedback on maintenance of DDA roads** has been developed for submitting feedback. Web based software has also been developed for monitoring and taking necessary action on feedback of DDA roads.
- **9.1.26** A mobile app for garbage and malba maintenance of DDA Community Halls/Parks/District Centers has been developed for submitting complaints. Web based software has also been developed for monitoring and taking necessary action on complaints.
- **9.1.27** A software for **DDA Aawasiya Yojna 2017** has been developed for submitting application details online by applicants and making payments through NEFT/ RTGS Net banking. Provision of printing application details as well as entering of offline application

details are available to the users of banks.

- **9.1.28** A web enabled software **Interactive Disposal of Land Management (IDLI)** has been developed for data capturing and retrieval of institutional properties. Various MIS reports have also been developed. Some others features like barcode generation, barcode reading, file location, dashboard etc. have also been developed.
- 9.1.29 Annual Performance Assessment Report (APAR) & Property Return Information System Management (PRISM) :- A web enabled software. is used to monitor the CR Report / Property Return of each employee of DDA submitted by the employee online.
- **9.1.30** Staff Benefit Fund For DDA :- It is a web enabled application that has been developed for allocating "DDA Staff Benefit Fund" under various categories for benefit of serving DDA employees, their family's members and dependents. The allocation of the fund is to be made based on the criteria for each category.
- **9.1.31** Daily Record of Task accomplished:- This web enabled application software has been developed for entering their daily work record by DDA employees. Various reports have been developed for DDA employee and HODs.
- **9.1.32** E-Tendering:- DDA is using the central public procurement portal system (http://eprocure.gov.in) of NIC for e-tendering activities in DDA from Nov, 2013.
- **9.1.33 Payroll:-** A software has been developed for processing salary of DDA employees. Various reports and salary slip are also been generated through this software.

9.1.34 E-auctioning:-

- E-auctioning has been implemented in DDA successfully for various types of properties.

9.2 Training Department

- **9.2.1** The Training Institute of DDA organizes training programmes for officials and officers of DDA. It also identifies the need to upgrade professional knowledge and skills of staff in various fields. The department also processes nominations received from various officers/officials to participate in various External Training Programmes organized by professionals institutions.
- **9.2.2** During the current year 2016-17 the Training Institute organized training courses for all categories of DDA employees as well as nominated them to participate in various courses, workshops, seminars, conferences, etc., organized by in House the external training courses organized professional institutions/ govt. agencies such as ISTM/UTCS, etc. The number of programmes organized and the number of participants are given below:-

- **9.2.4** The Training Cell conducted training programme for malis re-skilling for skilled workers under Skill Development Plan of MOUD in three groups for thirty days.





10.1 INTRODUCTION

As per the provision of MPD-2001, DDA embarked upon developing sports complexes in all the zones of Delhi. The first sports complex was opened at Siri Fort in 1989 and, thereafter, fourteen other complexes and two golf courses have been developed.

For the Commonwealth Games 2010, DDA developed stadia at Siri Fort for squash and badminton and at Yamuna Sports Complex for archery and table tennis. Both these stadia are being utilized for holding regional, national and international level tournaments and are also available for utilisation by the public.

Although these sports complexes are membership oriented having playing rights only, any member of the public can utilise the facilities on payment of the prescribed charges. Special concessions are available for students, senior citizens, schools, sports federations and associations.

Sports complexes are exclusively devoted to sports related activities and facilities for over 20 sports disciplines have been provided.

10.2 SPORTS INFRASTRUCTURE

The sports infrastructure developed by the DDA is as follows-

These do not include casual members, guests, etc. Approximately **65000** individuals utilise these facilities on a daily basis in addition to use by associations for training and for organizing sports events.

10.5 Sports Gala

A Sports Gala to promote participation in sports for members and their families is an annual feature at all complexes. Tournaments in individual sports such as Tennis, Squash, Badminton, Table Tennis, Billiards etc., for all age groups are conducted.

In addition, each complex also conducts an Invitational Tournament at school and State level in team sports as part of the gala and the winners in turn compete in the Invitational Tournament conducted by DDA.

10.6 Coaching — Regular coaching at all the sports complexes in various sports disciplines such as cricket, tennis, badminton, skating, aerobics, taekwondo etc., were organized. 156 individual coaching schemes are being run by professional coaches and approximately 8000 trainees attended the training. Approximately 270 talented trainees from weaker sections of society are being provided free coaching in various disciplines.

Summer Coaching- Special Summer Coaching Camps were also organized at all the Sports Complexes during the summer vacations of the Schools/ Colleges.

10.7 PROMOTION OF GOLF

Qutab Golf Course at Lado Sarai, India's first public golf course has gained immense popularity with around 300 rounds being played during weekends in peak season. The 9 hole public golf course at Bhalswa has made the game of golf easily accessible to the residents of North, West and East Delhi.

The mini golf course constructed at Siri Fort Sports Complex is also popular and extensively used.

The golf driving range at Siri Fort, Qutab and Bhalswa Golf Courses are used extensively by beginners, amateurs and professionals to improve their game.

10.8 Golf Coaching

One coaching camp was organised during the year by Qutab Golf Course.

Golf Tournaments

The Qutab Golf Course hosts several invitational golf tournaments sponsored by corporates. Two such tournaments are held every month during the golfing season. In addition, two medal rounds were organized by the Qutab Golf Course for its members.

10.9 SPORTS PROMOTION SCHEMES

DDA is conducting four sports promotion schemes in athletics, football, gymnastics and archery with a view to promote these sports at the grass-root level. The schemes are fully supported by DDA and are run under the guidance of expert advisors and experienced coaches.

10.10 Athletics Promotion Scheme (APS)

It is successfully running since 2001. Currently 33 athletes (22 boys and 11 girls) in the age groups of U-14 and U-19 years, are receiving coaching in their respective events. Trainees from the schemes participated in various State, Zonal and National athletics meets and won laurels for DDA. A few achievements are highlighted below:-

- In the National Junior Federation Cup held at Bangalore from 03.05.2016 to 05.05.2016, DDA athletes won 1 gold, 2 silver and 1 bronze medals.
- In Delhi State Athletics Championship 2016 held at Delhi from 18.06.2016 to 19.06.2016, DDA athletes won 5 gold and 3 silver medals.
- In National Senior Inter State Athletics Championship 2016 held at Hyderabad from 28.06.2016.to 02.07.2016, DDA athletes won 2 bronze medals.
- In the World School Championship held at Trabzon, Turkey from 11.07.2016 to 18.07.2016, DDA athletes
- In the Summer Athletics Meet 2016 held at Delhi from 22.08.2016 to 25.08.2016, DDA athletes won 16 gold, 3 silver and 3 bronze medals.
- In the Delhi Athletics Championship 2016 held at Delhi from 02.09.2016 to 04.09.2016, DDA athlete won 20 gold, 8 silver and 7 bronze medals.
- In the National Junior Athletics Championship 2016 held at Coimbatore from 10.11.2016 to 14.11.2016, DDA athletes won 3 gold, 3 silver and 1 bronze medals.
- In the Inter Zonal Delhi Schools Championship held, at Delhi from 22.11.2016 to 26.11.2016, DDA athletes won 19 gold, 10 silver and 2 bronze medals.
- In the CBSE National Athletics Championship held at Vadodara from 26.12.2016 to 30.12.2016, DDA athletes won '2 gold, 2 silver and 1 bronze medals.
- In the YMCA Athletics Championship held at Delhi from 27.01.2017 to 28.01.2017, DDA athletes won 20 gold, 10 silver and 4 bronze medals.

10.11 Football Promotion Scheme (FPS):

It is successfully running since 2002. Open selection trails for new trainees were held on 19th & 20th November, 2016 at Siri Fort Sports Complex and on 26th & 27th November, 2016 at Yamuna Sports Complex. Total 45 trainees were selected including reserve and 54 old trainees were retained. 45 trainees are receiving coaching at SFSC and 30 trainees are receiving coaching at YSC.

10.12 Major achievements of the trainees under the Scheme are as under:-

- Two trainees participated in U-17 State Nationals held at J & K in May, 2016.
- Three trainees participated in U-14 School Nationals held at Delhi in May, 2016.

11.10 PROPERTY TAX CELL:- It deals with settlement of property tax for DDA properties with MCDs. The property tax for properties under the control of DDA is being dealt with under the relevant provisions of Constitution of India, DMC Act and MoUD OMs of 2009 and 2015.

DDA has been regularly paying service charges for its properties as per decision taken in the meeting with Commissioners of MCDs on 08.07.2009.

14 Vigilance Department

- **14.1** Vigilance Department is responsible for implementation of Anti Corruption measures and checks on integrity in service, as per the instructions issued by the Central Vigilance Commission, Department of Personnel & training, Government of India and the Ministry of Urban Development from time to time.
- **14.2** In DDA, the Vigilance Department receives, scrutinizes and conducts in-depth investigation of complaints received from various sources and frames charge sheets in consultation with the CVC, wherever required. It also analyses inquiry reports and gives its comments for consideration of the Disciplinary Authorities. Further, appeals, review petitions, suspension and its review and regularization of suspension period are also dealt by it. Finally the Department suggests system's improvements based on observations while examining complaints, etc., which helps in preventive vigilance.

work done and measures proposed and implemented for systemic improvement in the department in the front of preventive vigilance measures were apprised and statistical figures projected with regard to disposal and pendency of complaints. All HODs of respective departments attended the meeting who were exhorted by Vice Chairman, DDA to respond to the requirements of the vigilance cases in a time bound manner for their early disposal.

14.4 Vigilance Awareness Week :

Consequent upon CVC's directions, DDA and its various offices located throughout Delhi observed Vigilance Awareness Week from 31.10.2016 to 05.11.2016 with the theme "Public participation in promoting and eradicating corruption".

Pledge was administered to all DDA officers and staff

on the opening day of the vigilance week by Vice Chairman, DDA. For effective implementation of Government's Official Language Policy, during the period from 01.04.2016 to 31.03.2017, four meetings of Official Language Implementation Committee were organised. With the

purpose to train employees in Hindi noting and drafting, 5 Hindi workshops were organised through which training was imparted to 5 officers and 116 employees to work in Hindi.

In September, 2016 'Hindi Prayog Protsahan Maas' was organised in which Hindi debates, Hindi notingdrafting, Hindi sulekh (for class-IV employees only), Hindi dictation (only for Assistants, Assistant Accounts Officers, Assistant Directors & equivalent officers and higher officers) and Hindi essay and Hindi general knowledge competitions were organised. 205 officers and officials participated in these competitions. Prizes given in these competitions amounted to ₹1,10,600/-. During the"Hindi Prayog Protsahan Maas' one Hindi workshop was also organised.

The Committee of Parliament on Official Language inspected the Office of Chief Engineer (Electrical) and Office of Chief Engineer (South Zone) on 07.06.2016 and 27.10.2016 respectively. For these inspections, Hindi Department provided assistance for filling questionnaire, translation and typing work.

The Committee of Parliament on Official Language also inspected DDA's head quarters at Vikas Sadan, INA on 06.01.2017. The inspection was sussessfully conducted and the Parliamentary Committee commended the work of the Official Language Department. Vice Chairman, DDA also appreciated the work of the officers/employees of the Department for their commendable efforts during this inspection and presented them with appreciation letters.

Besides the above, in compliance with the Government's Official Language Policy about 1243 pages were translated which included PAC paras, CAG's Reports, Standing Committee Report, Annual Report of 2015-16, DDA's Audit Report, articles of Vikas Varta, Training Department's booklet and matters pertaining to Standing Committee and Consultative Committee of Parliament. About 700 pages of DDA's website matter were also translated.

In addition to this forms, standard letters, notifications, press releases, tenders, advertisements, orders, circulars and establishment orders of various departments were also translated.



15.4 Public Relations Department

Public Relations Department of DDA is entrusted with the activities relating to image building of the organization through paid and unpaid publicity and to maintain cordial interaction with public using various modes of communication. Its other major functions include formulation of advertisement policy, fixing of advertisement rates, empanelment of advertisement agencies, publication of quarterly house journal. Besides this, the Department is also responsible for arranging Press Conferences/Press Trips, etc. Coverage of various functions, issue of press handouts, processing and follow-up / monitoring of grievances expressed through newspapers, receiving of delegates and issue of rejoinders are some of the other functions entrusted to the Department.

Activities performed for the period 1.4.2016 to 31.03. 2017

- 1. 21 press handouts. (both English and Hindi) were released highlighting the achievements, various activities and functions organized during the period. These press releases were covered both in print as well as in the audio-visual media. Apart from this, DDA's version for reports published in various newspapers were given to newspapers after obtaining information from the concerned departments.
- An audio-visual capsule on Doordarshan titled "Dateline - Delhi" highlighting achievements of DDA is being telecast fortnightly since July, 2006. During the period 1.4.2016 to 31.3.2017, inputs for episodes were prepared and 15 episodes telecast on Doordarshan.
- 3. 79 advertisements (English and Hindi) were published in various newspapers.
- 4. 4 press clippings which appeared in various newspapers, were followed up to get the individual grievances redressed and also 4 rebuttals were issued.
- 5. 67551 letters were received and 65612 letters dispatched through computerized Receipt and Despatch Counters at Vikas Sadan Reception.
- 6. 519 new books were added to the library at Vikas Sadan. About 2176 press clippings pertaining to DDA were extracted from daily newspapers and circulated to senior officers for information or response, if any.
- 7. Annual Report 2015-16 was compiled, designed and printed.
- 8. Four issues of Delhi Vikas Varta were edited, printed and distributed.

- 9. 82 functions were covered by Photo Section. 6156 photographs were taken and 2572 photographs were issued for publication and record.
- 10. During the period under reference, contract advertisement rates for the year 2017-18 were negotiated with various leading newspaper publications and no increase allowed over and above the approved contract rates for the year 2016-17.

Quality Assurance Cell

- 16.1 Delhi Development Authority is committed to provide quality products at reasonable cost to the customers, keeping in mind "the customer is supreme and should be benefitted". The quality is therefore drilled not only into activities of various serving sections of DDA but also the quality in engineering and horticulture wings for all construction and development works.
- **16.2** Quality of construction is supervised and monitored regularly by Junior Engineers, Assistant Engineers and Executive Engineers at field level and checked internally at the level of Superintending and Chief Engineers and externally at the level of Quality Assurance Cell of DDA by conducting periodic inspections of the works to ensure that the works are executed strictly in accordance with contract conditions, specifications and drawings.
- 16.3 The QA Cell, created in 1982, includes 9 Junior Engineers, 10 Assistant Engineers (8-Civil and 2-Elect.); 7 Executive Engineers (6-Civil and 1-Elect.), one Deputy Director(Hort.) and one Superintending Engineer. The Cell is headed by a Chief Engineer. The Cell is playing a vital role in quality assurance, which oversees not only the quality of material and workmanship but also the quality of planning, designing, contract documents, specifications, etc., and issues necessary guidelines, circulars, etc., from time to time. In order to enforce the compliance of observations made by Third Party Quality Assurance agencies, Circular No. 213 has been issued by QA Cell wherein it has to monitor inspection reports of TPQA.

For major works, a system of third party inspection has been introduced and agencies like CRRI, NCCBM, IIT, RITES, Sriram Institute for Industrial Research, etc., have also been engaged as consultants. QAC is also associating itself with the third party while taking 10% of total samples of materials to be used on these works for conducting required tests to ensure quality of materials.

16.4 Major projects are inspected by QA Cell at least twice, i.e., at foundation stage, super-structure stage and third time with the approval of Engineer Member, DDA or on receipt of any complaint.

Due emphasis is given for maintenance of records on procedural, material and workmanship aspects which are duly examined during quality audit. The deficiencies noticed, if any, are promptly brought to the notice of the concerned officer for suitable and effective administrative/contractual action and remedial measures and a close watch is kept on compliance of the observations. QAC is also being assigned special duties by the Works Advisory Board like carrying out inspection of materials manufactured at different factories for use in major projects of DDA and also to ensure the proper recording of levels of earth work in road works.

- 16.5 The specifications and technologies adopted are being reviewed regularly and suitably amended to meet the present requirement and environmental considerations. Use of new construction material, new techniques, such as prefab technology in housing projects, use of mix design/RMC, etc., have been encouraged. Control on time and cost over runs without compromising the quality, functional requirement, aesthetics and structural soundness of buildings is being effectively monitored.
- 16.6 DDA has been striving for continual improvement of services and quality of work. Interaction with the field staff is being conducted during various inspections for bringing out various suggestions for quality improvement. The QAC officers and other engineering staff are regularly sent for refresher courses/ training programmes being conducted for their skill upgradation.
- 16.7 Emphasis has also been laid to clear long pending QAC paras and closure of cases for which a drive was launched by QAC for cases upto 31.3.2005. The paras having no financial implication were settled and several cases closed. As a result, a good number of cases have reached their conclusion stage. Efforts have been made to delegate the jurisdiction to Zonal Chief Engineers for satisfaction of procedural paras. The QAC has kept only those paras which have financial implications or involve specific technically vital issue. QAC has played an advisory role also indirectly to the field engineers during zonal review meetings and interaction among engineers during inspection.

- 16.8 Complaints as and when received through Vice Chairman, Engineer Member and Vigilance Cell are also got investigated through QA Unit and vigilance angle involved, if any, is taken care by Vigilance Cell.
- 16.9 Selection of material for works, collection of representative samples and their testing in reputed and reliable labs is of utmost importance. QA Cell has a well-equipped testing lab manned by two Assistant Engineers and two Junior Engineers located at Asian Games Village Complex. Testing facilities for various materials are available in this lab. Though day to day routine tests are conducted at site by the field staff, the random samples collected by QA team during their inspections are mostly got tested in this QA Lab. In order to induce more confidence among the people at large, the present system of testing has been streamlined and revised guidelines have been issued. In this regard emphasis is laid on testing of at least 10% samples in outside labs. As such, other labs like Sriram Test House, NTH, Delhi Test House and a number of private testing laboratories are also on the panel of DDA for testing of materials.
- **16.10** DDA QAC has an IS/ISO 9001:2008 license. The Quality Assurance Cell has made concerted efforts to improve quality systems and complied with

quality manual in line with Quality Management System of ISO-9001-2008 which emphasize on organization profile, quality management, quality policy and objectives, quality management system, management responsibility, resources management, service realization, etc. DDA's QA Cell got the IS/ISO 9001:2008 licence when all parameters envisaged were fully achieved and Bureau of Indian Standards was satisfied with the quality management system adopted in DDA. The Bureau of Indian Standards, granted Quality Management Systems Certification license CRO/ QSC/L-8002720 for IS/ISO 9001:2000 to DDA in March 2007. The certification is reviewed every year and renewed after every three years. It was last renewed on 16.08.2016 and is valid upto 14.09.2018.

- 16.11 A mobile application for e-measurement of work done and to be paid to various agencies was designed and developed in-house by QAC & System wings. The app was launched on 01.11.2015 for works costing more than ₹ 1.50 crores and subsequently all payments of all original works, maintenance works and petty expenses are made through this mobile app.
- **16.12** Comparative data of achievements for the past two years and the achievements during the year 2016-17 and the targets for the year 2017-18 are as given in the following table:
