The Estimate Approval Committee, DDA is pleased to accord the revised A/A & E/S for the above said work for an amount of Rs. 15,91,49,625/- (Rupees Fifteen Crores Ninety-One Lakh Forty-Nine Thousand Six Hundred Twenty-Five Only) including 3% Contingencies and 11.25% Departmental Charges.

The expenditure shall be charged under the head of a/c of Nazul Account-II to the Major Code (Head) of 2422 with sufficient budget provisions under the budget code 24095850 before carrying out the work.

Finance Member, DDA has accorded the Financial Concurrence to the preliminary estimate for the above mentioned work for an amount Rs. 15,91,49,625/- (Rupees Fifteen Crores Ninety-One Lakh Forty-Nine Thousand Six Hundred Twenty-Five Only) which includes works outlay of Rs. 14,30,55,843/- (Rupees Fourteen Crores Thirty Lakhs Fifty-Five Thousand Eight Hundred Forty Three Only) i/c 3% Contingencies & 11.25% Departmental Charges i.e. Rs.1,60,93,782/- (Rupees One Crore Sixty Lacs Ninety Three Thousand Seven Hundred Eighty Two Only) and conveyed by AO(WAC)-I, DDA vide U.O. F4(412)WAC-I/2021-22/F4(19)AE-IV/WD-3/DDA/86 dated 02.06.2021 subject to compliance of specific conditions at Sl. No. 1 to 11 of the Financial Concurrence.
