Twelve Crore Eighteen Lakhs Twenty Four Thousand Three Hundred and Fifty Only) conveyed by AO (Works-II)/DDA vide U.O. No. F2(12)/AO(W)/PE/DDA/2024-25/40 Dated: 13/06/2024. & Sanction No. 04/2024-25 subject to compliance of specific conditions at SI. No. 1 to 15 of the Financial Concurrence.

N.O.W.:- Revised Preliminary Estimate of development of Golf Course including drainage bunkers, Green trees, Grassing Plantation, Cart Path, Lakes & Irrigation Works at Sector-24, Dwarka (Development of Golf Course at Sector-24, Dwarka, New Delhi).

Finance Member, DDA has been pleased to accord financial concurrence to the revised preliminary estimate, amounting to Rs. 1,37,92,35,246 (Rupees One Hundred Thirty-Seven Crore Ninety-Two Lac Thirty-Five thousand Two Hundred and Forty-Six Only) including 3% contingencies and 11.25% Departmental charges.

The above financial concurrence shall be subject to the following conditions:-

- 1. The RPE has been broadly examined on the basis of documents submitted along with the RPE. The correctness of the nomenclature, rates, analyzed items, items unit, quantities and amount shall lie with TS Authority.
- 2. All mandatory approvals and drawings are to be sought by the TS authority wherever required.
- 3. Expenditure will be incurred only after ensuring the budget provision in the relevant year of execution of work and ensuring sanction of A/A & E/S.
- Each work included in the RPE shall be executed only through proper call of tenders
  after completing all the codal formalities and departmental instruction issued from
  time to time.
- 5. Utmost economy in the expenditure shall however be ensured by the Engineering Wing during the execution of work.
- 6. Engineering Wing to ensure feasibility w.r.t. dimensions existing services, etc.
- 7. RPE will require formal approval of EAC before execution of work.
- 8. The correctness of estimates may be thoroughly examined by TS authority before making any payment to the executing agency.
- 9. The sanctioning authority of deviation/SI/EI will invariably ensure that there is no undue benefit accrues to the executing agency.
- 10. Necessary approval has to be taken from Forest Department for cutting of trees, if required. Any other necessary approval from statutory/ government body may be taken if required.
- 11. Provisions kept in the RPE for different sub heads i.e. Civil, Horticulture, contingencies & Departmental Charges shall not be misused/diverted for any other sub heads.
- 12. Engg. Wing/Hort. Wing concerned shall ensure that the land under encroachment is vacated before actual execution of work, if any.
- 13. It shall be ensured by TS Authority & Dy. CAO/Sports that the expenditure on the work charge establishment and petty items does not exceed the amount of 3% contingencies.
- 14. It shall be ensured by CE/Sports that Extra/ Substitute items shall be paid only for the works not considered in the scope of work as per agreement.
- 15. The TS Authority shall ensure that all provisions of CPWD Manual (along with subsequent amendments) and financial delegations are duly complied.
