CORRIGENDUM

In partial modification to Minutes of Meeting for 179th Estimate Approval Committee (EAC) (NA-II) held on 07.11.2025 and circulated vide letter no. EM1(37)87/Vol.179/220 dated 12.11.2025 respectively, the following modification in the minutes of agenda item no.- 1/179 are as under: -

Ref.	Original Minutes of Meeting	Modification
Para 2, Item no 1/179	CE(Horticulture) explained the scope of work taken in this estimate. On being enquired if the permission from Hon'ble NGT has been taken prior to carrying out the work in Ozone area, to which Director (Landscape) informed that a formal intimation letter was sent to NGT and no such permission is required. Further, the Committee asked the reason for using wooden work in multi play station as the area is flood prone. Director (Landscape) stated that the area is at higher level with low probability of flooding, further nearby Bansera park has bamboo theme and same has been taken to match the theme.	CE (Horticulture) explained the scope of work taken in this estimate. On being enquired if the permission from Hon'ble NGT has been taken prior to carrying out the work in O-zone area, to which it was informed that no written communication has ever been sent by Landscape Dept. to NGT for this project. Further, the Committee asked the reason for using wooden work in multi play station as the area is flood prone. Director (Landscape) clarified that the proposed location of the houseboat component does not fall within the 1:25-year floodplain.
Para 4, Item no 1/179	The committee emphasised that all the NGT's directions and guidelines must be followed in the implementation of this project. In addition, as the site area is vulnerable to flood, it must be ensured that all structure considered in this estimate must be designed to be flood resistant. On query of regarding possibility of getting Electrical connection from power supply company in the O-Zone, the CE(Hort.) replied in affirmative.	The committee emphasised that the proposal is subject to obtaining all requisite statutory approvals. In addition, as the site area is vulnerable to flood, it must be ensured that all structure considered in this estimate must be designed to be flood resistant. On query of regarding possibility of getting Electrical connection from power supply company in the O Zone, the CE(Hort.) replied in affirmative.

Rest of the content of the minutes will remain same.
