The agenda note was submitted by CE (Project) vide no. F(05)FO to CE(P)/2019-20 dated 18/02/2020. The case was presented by CE (Project) before Board with the recommendation for acceptance of lowest bid of L1 bidder i.e. **M/s GSBA Builders Pvt. Ltd.** at negotiated amount of Rs. 62,39,67,275.00 which are 11.06%

below the justified amount i.e. Rs. 70,15,43,027/- and 11.06% below the estimated cost i.e. Rs. 70,15,43,027/- as worked out by CE (Project) for above work.

The A/A &E/S for "Upgradation of District Centre at Nehru Place" was accorded vide No. EM6(15)2018/Est./Pt./4363 dated 22.11.2018 for Rs. 182.59 Cr. The corresponding amount available in A/A & E/S for this part of work is Rs. 44.38 Cr. The Project is funded under UDF.

The Board conveyed displeasure that percentage (%) rate tender should have been called rather than item rate tender. The CE(Project) stated that the point is noted and shall be meticulously followed in future. After due discussion & deliberations, Board agreed that with recommendation of Chief Engineer (Project) and accepted the tender of **M/s GSBA Builders Pvt. Ltd.** at negotiated amount of Rs. 62,39,67,275.00 which are 11.06% below the justified amount i.e. Rs. 70,15,43,027/- and 11.06% below the estimated cost i.e. Rs. 70,15,43,027/- subject to **compliance of directions as above**. Chief Engineer (Project) shall ensure fulfillment of all codal formalities before award of work. Further the quality of work is to be ensured by Chief Engineer (Project Zone).
