Whereas M/s. Hanuman Construction Company was prequalified on the basis of the documents of two agreements submitted by the agency for up gradation of Shri Fort Sports Complex. In which the document of one agreement has not been verified by the issuing authority.


Whereas as per clause No. 19(a) of NIT, The Project Director (Sports) recommended to debar the agency for tendering in DDA.

The agency, therefore, was served a Show Cause Notice to submit his explanation in the above matter. The agency submitted explanation vide its letter dated 04.06.2015 and 26.06.2015.

Whereas the reply was sent to CE(Project) for submission of his specific comments. The comments of CE(Project)/Project Director (Sports) were received wherein he recommended that the disciplinary action against the agency be taken.

The case is entirety was placed before the CRB in its meeting held on 08.12.2015. Now after careful consideration, the CRB has decided to debar, M/s. Hanuman Construction Company from further tendering in DDA for a period of one year from the date of issue of this order.
