I. WAB AGENDA of CE (Rohini):

Name of work: -Request for proposal (RFP) for Engagement of DEA Empanelled Transaction Advisor for "Providing feasibility studies and selection of Developer for In-situ Slum Redevelopment/ Rehabilitation of jhuggi cluster at ten different locations in Delhi to be taken up on PPP mode."

Subject: - Bid acceptance of E&Y LLP as a transaction advisor for in-situ slum projects-regd.

The agenda note of above mentioned subject was submitted by Chief Engineer (Rohini) before the 6th WAB meeting held on 09.09.2024 at 05:00 PM for accepting bid of L1 bidder i.e. M/s Ernst &Young LLP at their quoted rate of Rs.5.34 Cr. which is 84.61 % below w.r.t. the estimated cost of 34.73 Cr. of the related works not put to tender.

It was informed by CE(Rohini) that the consultancy of the following in-situ rehabilitation projects were to be taken up by the transaction advisor as per the scope of RFP.

- At the very outset Vice Chairman desired to be made aware of the methodology adopted to arrive at the estimated cost of Rs. 34.73 Cr. It was briefed by CE(Rohini) that as CPWD Work Manual, the 1% of the total project cost i.e. purely construction cost of SRP Asset of each of the ten in-situ slum rehabilitation/redevelopment project for which the consultancy is to be taken up ,has been calculated as the estimated cost of consultancy related works and thus, in present case M/s Ernst &Young LLP has quoted amount of Rs. 5.34 Cr. which is 84.61% below the estimated cost.
- ➤ Vice Chairman, DDA, during the course of discussion, directed to shortlist some ISR sites where feasibility studies may be taken up during the initial phase. The concerned Engineering staff and the Architect Wing, after discussion along with Housing officials, suggested the below mentioned projects for the said purpose.
 - a) In-situ Slum Redevelopment/ Rehabilitation of jhuggi cluster at AO Block, Shalimar Bagh & AU Block, Pitampura.
 - b) In-situ Slum Redevelopment/ Rehabilitation of jhuggi cluster at Dilshad Garden, New Delhi.
 - c) In-situ Slum Redevelopment / Rehabilitation of jhuggi cluster at Kalkaji Extension Ph-II (Jawaharlal Nehru Camp & Navjeevan Camp).
- It was further informed that the amendments in MPD 2021 for ISR (In-Situ Rehabilitation) is pending for notification and is likely to be notified by the Ministry of Housing and Urban Affairs in the upcoming one or two months, in which case the activities undertaken by the agency, if engaged now, will have to be done again in light of new amended and notified rules.

Decision:

After due discussion and deliberation, the agenda was deferred until the amendments in MPD-2021 for ISR (In-Situ Rehabilitation) get notified by MoHUA, upon which the revised RFP and DPR are to be prepared. The board further gave directions to seek extension of validity of bid made by M/s Ernst & Young LLP by one month till 31.10.2024.
