This accord of A/A & E/S is subject to compliance of the following conditions:

1. The responsibility of correctness of nomenclature rates, item, units, quality, quantity, rates and amount shall be with the Technical Sanctioning authority.
2. Utmost economy in expenditure shall however be ensured by Engineering Wing during execution.
3. Expenditure will be incurred only after ensuring the budget provision in the relevant year of execution of work.
4. Each Work included in the PE shall be executed only through proper call of tenders after completing all codal formalities and departmental instructions issued time to time. Budget code to be allotted to this work.
5. The correctness of the estimate may thoroughly be examined by the Technical sanctioning authority before making any payment to the executing agency.
6. The sanction authority of deviation/SI/EI will invariably ensure that there is no undue benefit should occur to the executing agency.
7. All the mandatory approvals, of Technical Sanctioning authority issuance of drawings viability of the project are to be taken before call of tenders.
8. Before making any payment, all codal formalities will be completed as per provision of CPWD Manual and departmental instruction issued from time to time.
9. To reassure that lowest reasonable rates have been taken into account as per prevailing market conditions in all cases where DSR 2018 rates have not been considered.
10. Engineering Wing shall ensure the feasibility w.r.t. dimensions, existing services etc.
11. Provision kept in PE for different sub heads i.e. civil, electrical, horticulture, contingency & departmental charges shall not be misused/diverted for any other subheads.
12. Necessary approval has to be taken from the forest department for cutting of trees if required.
