Chief Engineer (Rohini Zone) presented the above item in the 144th EAC meeting held under the chairmanship of VC, DDA on 17.02.2020 at 05:00 PM for approval. The minutes of the above meeting was circulated vide EM.1(37)87/Vol.134/504 dated 28.02.2020.


The Estimate Approval Committee, DDA is pleased to accord the A/A & E/S for the above said work for an amount of Rs. 11,78,80,617/- (Rupees Eleven Crores Seventy Eight Lacs Eighty Thousand Six Hundred Seventeen Only) which includes 3% Contingency & 11.25% departmental charges.

The expenditure shall be charged under the head of a/c of Nazul A/C-II to the Major Code (Head) of 2421 and Minor Code (Head) of 10 with sufficient budget provisions under the budget code 24025133 before carrying out the work.

Finance Member, DDA has accorded the Financial Concurrence to the preliminary estimate for the above mentioned work for an amount of Rs. 11,78,80,617/- (Rupees Eleven Crores Seventy Eight Lacs Eighty Thousand Six Hundred Seventeen Only) which includes 3% contingencies i.e. Rs.30,86,217/- (Rupees Thirty Lacs Eighty Six Thousand Two Hundred Seventeen only) and 11.25% departmental charges, i.e., Rs.1,19,20,512/- (Rupees One Crores Nineteen Lacs Twenty Thousand Five Hundred Twelve Only) conveyed by Accounts Officer (WAC)/DDA vide U.O. No.F4(391)WAC-I/2019-20/F3(184)EE/ELD-9/2018/77/35 dated 18.12.2019 and corrigendum issued vide even no.35 dated 30/01/2020 & sanction No. 18/2019-20 subject to compliance of specific conditions at Sl. No. 1 to 10 of the Financial Concurrence.

This accord of A/A & E/S is subject to compliance of the conditions laid down in Financial Concurrence with Sanction No.18/2019-20 and 144th EAC Minutes of Meeting as well as all other codal formalities and departmental instructions/circulars issued time to time.



The above financial concurrence shall be subject to the following conditions:-

1. The PE has been broadly examined on the basis of documents submitted. The correctness of the estimate, nomenclature, rates, analyzed items, items unit, quantities and amount shall lie with TS Authority.
2. Expenditure will be incurred only after ensuring the budget provision in the relevant year of execution of work and ensuring sanction of A/A & E/S.
3. Each work included in the PE shall be executed only through proper call of tenders after completing all the codal formalities and departmental instructions issued from time to time.
4. All mandatory approvals and drawings are to be sought by the TS authority wherever required.
5. Utmost economy in the expenditure shall however be ensured by the Engineering Wing during the execution of work.
6. Engineering Wing to ensure feasibility w.r.t. dimensions, existing services, etc.
7. PE will require formal approval of EAC before execution of work.
8. The sanctioning authority of deviation/SI/EI will invariably ensure that there is no undue benefit accrues to the executing agency.
9. Necessary approval has to be taken from Forest Department for cutting of trees if required.
10. Provisions kept in the PE for different sub heads i.e. Electrical, contingencies & Departmental Charges shall not be misused/ diverted for any other sub heads.


