The two members viz. Chief Engineer (Building/Project), Project Zone, PWD, GNCTD and Joint Secy. Finance, Delhi Admn. were not present in the meeting.

The Vice-Chairman, DDA presided over the meeting, agenda for which had been circulated vide this office letter No. EM/1/0002/2020/37/87/-O/o EO-II to EM/1349 dated 05.10.2020.

The following items were discussed in the meeting and decisions taken are as under:

Rohini Zone

1. Item No. 01/2020

Name of Work: Development of 60.34 Hact. (234.07 Hact.) of land at Sector-41 (Part) in Rohini, Phase-V.

The agenda was presented by Shri Ashwani Kumar, CE(Rohini) explaining about the details of the works to be taken up under this estimate. Out of the total land parcel of 234.07 Hact., the proposal is for the development work to be carried out for 60.34 Hact. of land belonging to DDA.

The Financial concurrence to the preliminary estimate for the work of Development of 60.34 Hact. (234.07 Hact.) of land at Sector-41 (Part) in Rohini, Phase-V has been accorded by Finance Member, DDA vide sanction No. 8/2015-16 for an amount of Rs. 150,48,94,000/- (Rupees One Hundred Fifty Crores Forty Eight Lacs Ninety Four Thousand Only) and conveyed by Sr. Accounts Officer(W)-111/DDA vide No. WAC-111(107)/DDA/2015-16/Est./206 dt.29.07.2015.

The committee expressed its concern over the probable increase in the cost of the estimate as the Finance Concurrence accorded in the year 2015 and is 5 years old. In this regards, Chief Engineer (Rohini), DDA informed the committee that the impact of increase in cost index during this period on the project would be of the order of 7% only and considering the overall market trend, the actual cost of execution is likely to be within the Financial Concurrence given.

The committee directed the Chief Engineer (Rohini) to parallelly refer to the Planning Wing of DDA to review the earmarked area/land use for various public facilities/utilities e.g. schools. ESS etc. as per latest norms /master plan. It was also pointed out that now distributed STP's are proposed to be provided in each sector and overall water requirement reduced by recycling of treated water within the sector. This may be kept in mind while designing/detailing the services, issue of technical sanctions and actual infrastructure charges to be paid to DJB etc. However, before the issuance of NIT, compliance of issues as raised above be submitted to VC, DDA.

After due discussions and deliberations, the Committee approved the estimate from administrative point of view in the meeting held on 07.10.2020 under the Chairmanship of Vice-Chairman, DDA as per details given below:-
