Chief Engineer (East Zone) presented the above item in the 147<sup>th</sup> EAC meeting held under the chairmanship of VC, DDA on 08.09.2020 at 04:00 PM for approval. The minutes of the above meeting was circulated vide EM/1/0001/2020/37/87/- O/o EO-II to EM/1337 dated 01.10.2020.

The Estimate Approval Committee, DDA is pleased to accord the A/A & E/S for the above said work for an amount of Rs. 21,47,71,792/- (Rupees Twenty One Crores Forty Seven Lacs Seventy One Thousand Seven Hundred Ninety Two Only) including @3% contingencies and @11.25% departmental Charges.

The expenditure shall be charged under the head of a/c of Nazul A/C-II to the Major Code (Head) of 2422 and Minor Code (Head) of 12 with sufficient budget provisions under the budget code 24018806 before carrying out the work.

Finance Member, DDA has accorded the Financial Concurrence to the preliminary estimate for the above mentioned work for an amount Rs. 21,47,71,792/- (Rupees Twenty One Crores Forty Seven Lacs Seventy One Thousand Seven Hundred Ninety Two Only) which includes 3% contingencies, i.e., Rs.56,22,912/- (Rupees Fifty Six Lacs Twenty Two Thousand Nine Hundred Twelve Only) and 11.25% departmental charges, i.e., Rs.2,17,18,496/- (Rupees Two Crores Seventeen Lacs Eighteen Thousand Four Hundred Ninety Six Only) and conveyed by Accounts Officer (Works)II/DDA vide No. F4(29) A E-1/RPD-9/EZ/DDA/2019-20/44 dt.31.07.2020 & sanction No. 09/2020-21 subject to compliance of specific conditions at Sl. No. 1 to 13 of the Financial Concurrence.

This accord of A/A & E/S is subject to compliance of the conditions laid down in Financial Concurrence with Sanction No.09/2020-21 and 147<sup>th</sup> EAC Minutes of Meeting as well as all other codal formalities and departmental instructions/circulars issued time to time.

Finance member, DDA has been pleased to accord financial concurrence to the Preliminary Estimate/Appraised Cost, for the above mentioned project for a sum of Rs Rs. 21,47,71,792/- as per detail overleaf:

The above financial concurrence will be subject to the following conditions:-

1. The PE has been broadly examined on the basis of documents submitted along with the PE. The correctness of the nomenclature, rates, analyzed items, items unit, quantities and amount shall lie with TS Authority.
2. Expenditure will be incurred only after ensuring the budget provision in the relevant year of execution of work and ensuring sanction of A/A & E/S.
3. Each work included in the PE shall be executed only through proper call of tenders after completing all the codal formalities and departmental instruction issued from time to time.
4. All mandatory approvals and drawings are to be sought by the TS authority wherever required.
5. Utmost economy in the expenditure shall however be ensured by the Engineering Wing during the execution of work.
6. Engineering Wing to ensure feasibility w.r.t. dimensions existing services, etc.
7. PE will require formal approval of EAC before execution of work.
8. The correctness of estimates may be thoroughly examined by TS authority before making any payment to the executing agency.
9. The sanctioning authority of deviation/SI/EI will invariably ensure that there is no undue benefit accrues to the executing agency.
10. Necessary approval has to be taken from Forest Department for cutting of trees, if required.
11. Provisions kept in the PE for different sub heads i.e. Civil, Horticulture, contingencies & Departmental Charges shall not be misused/diverted for any other sub heads.
12. Engg. Wing shall ensure that the land under encroachment is vacated before actual execution of work
13. Engg. Wing may ensure to comply with the relevant instructions issued by Hon'ble NGT and other statutory agencies from time to time in this regard.

**SH: Electrification of Residential Plotted Pocket-1, Block-H, Sector-18, Rohini.**

The agenda was presented by Shri Ashwani Kumar, CE(Rohini) explaining that the works are to be executed by TPDDL and the estimate has the approval of Delhi Electricity Regulatory Commission (DERC).

The Financial concurrence to the preliminary estimate for the work of D/o 2.97 Hact. land of Pocket-1, Block-H, Sector-18, Rohini has been accorded by Finance Member, DDA vide sanction No. 25/2019-20 for an amount of Rs. 8,14,26,000/- (Rupees Eight Crores Fourteen Lacs Twenty Six Thousand Only) i/c 18% GST charges and conveyed by A.O.(WAC)-I/DDA vide U. O. F4(395)/WAC-1/2019-20/F3(131)/EE/ELD9/DDA/545/40 dated 20.02.2020.

**Name of Work: Restoration and rejuvenation of Yamuna River Flood Plains.**

**Sub-Head: Old Railway Bridge to ITO Barrage (Western Bank) – Asita West. Development of land beyond Geeta Colony Bridge to Shantivan Drain.**

The agenda was presented by Shri Sham Sunder Garg, CE(East Zone) explaining about the detail of various components of work to be taken up under this estimate.

The Financial concurrence to the preliminary estimate for the work of Restoration and rejuvenation of Yamuna River Flood Plains has been accorded by Finance Member, DDA vide sanction No. 09/2020-21 for an amount of Rs. 21,47,71,792/- (Rupees Twenty One Crores Forty Seven Lacs Seventy One Thousand Seven Hundred Ninety Two Only) and conveyed by Accounts Officer (Works) II/DDA vide No. F4(29)AE-I/RPD-9/EZ/DDA/2019-20/44 dated 31.07.2020.

It was pointed out, during discussion that there was no need of a parallel motorable road to connect the three entry points when there was a service road of the main PWD road just outside running along this stretch. Also, instead of two amphitheaters, one would be sufficient, considering the general location of this project site. The Chief Engineer (EZ), DDA informed that by reducing the length of path for vehicular movement and providing only one no. Amphitheater of big size in the estimate, there would be a scope of saving of Rs. 20 Lacs (approx.) which can be utilized in providing improved lighting near entry/ exit gate, parking area and for CCTV provision at vulnerable points. The possibility of providing solar lights shall also be explored. The drawings shall be accordingly revised and issued by Landscape wing of DDA.


After due discussions and deliberations, the Committee approved the estimate from administrative point of view in the meeting held on 08.09.2020 under the Chairmanship of Vice-Chairman, DDA as per details given below:-
