

Name of Work: Development of Bharat Vandana Park at Sector-20, Dwarka, New Delhi. Budget Code: 24503004 under Nazul A/c-II.

Finance Member, DDA has been pleased to accord financial concurrence to the preliminary estimate, amounting to Rs.523.36 Crores (Rupees Five Hundred Twenty Three Crores and Thirty Six Lacs only) Inclusive of PMC charges @8% plus GST @18% on PMC charges for the above mentioned work, as per abstract of cost overleaf.

In this regard, it is added that:-

- a. Since, per square meter cost of the development park has not been worked out and has not been compared with recent cost of work awarded for such works, it is enjoined upon the technical wing that they will ensure that the cost included in this DPR is lowest for various items as taken in DPR. Thereby, it will be ensured that the project is taken up at the lowest competent
- b. Since, social cost benefit of the project has not been analyzed it is expected that Chief Engineer(Dwk) would work out the same and ensure that the project is beneficial for the cost incurred. It is urged that the same may be worked out, analyzed appraised and kept in the records so that the same is available for future inspection. Engineering wing shall ensure that the departmental charges relevant to the proposed head of accounts is included in the P.E.

The above financial concurrence will be subject to the following conditions:-

- 1. The responsibility of correctness of nomenclature rates item, units, quality, quantity, rates and amount shall be with the Technical Sanctioning authority.
- 2. Utmost economy in expenditure shall however be ensured by Engineering Wing during
- 3. Expenditure will be incurred only after ensuring budget provisions in the relevant year of execution under the head of Accounts NA-II and ensuring the sanction of the AA & ES.
- 4. Work included in the PE will be required to be executed through proper call of tenders after completing all codal formalities and departmental instructions issued time to time.
- 5. The sanction authority of deviation /SI/EI will invariably ensure that there is no undue benefit should accrue to the contractor.
- 6. Approval of all concerned agencies is obtained in advances.
- 7. All the mandatory approvals, of Technical Sanctioning authority issuance of drawings, viability of the project are to be taken before call of tenders.
- 8. Before making any payment all codal formalities will be completed as per provision of CPWD Manual and departmental instruction issued from time to time.
- 9. Provision kept in the PE for the concerned work will be subject to technical check of the approval of Competent Authority.
- 10. Provision available in AA/ES for different heads i.e. Civil, Hort., Electrical etc., shall not be used in other sub Heads.
- 11. Adequate provision for third party Quality Assurance is kept.

It shall be ensured by the concerned Engineer that the scope of work mentioned in the DPR shall be strictly followed.
