Minutes of the meeting held on 22.08.2022 at 03.00 P.M. under the Chairmanship of the Chief Secretary, Delhi

A meeting was taken by the Chief Secretary at 05:00 P.M. on 22.08.2022 in the Conference Room at 5th Level, A-Wing, Delhi Secretariat, IP Estate, New Delhi, with the officers of DDA, MCD, Delhi Police, DPCC, Delhi Fire Service, DJB and the Departments of Labour and Power to streamline the process of granting permissions to hold public activities such as Ram Leela etc.

2. It has been directed by the Chief Secretary that the online single window portal must be made available by all the departments concerned so that the organizers are able to apply through the online system and obtain the necessary permits / licenses in a time bound manner without having to run from one office to other physically.

3. Accordingly the following nodal officers will ensure the compliance of directions and process the applications in a time frame of five working days.

4. Once the application is received by the Licensing Department of Delhi Police they will forward the same to Local Police, Traffic Police, MCD, Power, Labour and Delhi Fire Service

who in turn fulfill their response to Licensing Department within five working days, otherwise it would be presumed that NOC is granted by them and Licensing Authority may issue permission accordingly.



It has been directed that Licensing Authority, DDA should mention in the permission that the organizer shall fix surveillance cameras in place where Ram Leela function is going to be organized on a big scale and substantial number of people are expected in such places and the CCTV feed is being kept at one centralized location for monitoring by the Local Police.

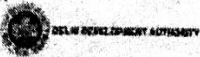

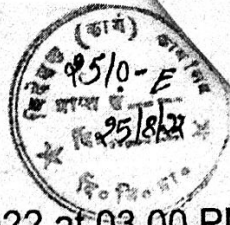
