OFFICE ORDER

Subject Eligibility criteria according to enhanced tendering limit in DDA for contractors registered with DDA, CPWD and those of appropriate list of MES Civil wing, BSNL and Railways (other than DDA Contractors)

The eligibility criteria according to enhanced tendering limit in DDA for contractors registered with DDA, CPWD and those of appropriate list of MES Civil wing, BSNL and Railways (other than DDA Contractors) is hereby circulated as under:

Item rate/percentage tender are invited for the work on behalf of DDA from the approved and eligible contractors of DDA & CPWD and those of appropriate list of MES, BSNL, and Railway which shall be opened on the same day.

The enlistment of the contractors should be valid on the last date of sale of tenders.

In case only the last date of sale of tenders in extended, the enlistment of contractor should be valid on the original date of sale of tenders.

In case both the last date of receipt of application and sale of tenders are extended the enlistment of the contractors should be valid on either of the two dates, i.e. original date of sale of tender or on the extended date of sale of tenders.

1.2 For works costing upto Rs. 1.30 Crore in case of Civil category tenders shall be issued to contractors registered with DDA only.

1.3 For works costing above Rs. 1.30 Crore upto 4 Crores, tender shall be issued to DDA & CPWD enlisted contractors as per their enlistment. The tenders shall also be issued to non-DDA, non-CPWD contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost in the last five years.

1.4 For works costing above Rs. 4 crores but upto Rs. 50 crores, the tender shall be issued to DDA contractors as per their enlistment. The tender shall also be issued to non-DDA contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost or two similar nature of works, each of value not less than 50% of the estimated cost or one similar nature of work value not less than 80% of the estimated cost in the last 7 years ending last day of month previous to the one on which the tenders are invited. Note – Class-II contractors of DDA & CPWD shall also be eligible if they satisfy the above criteria.

1.5 For work costing above Rs. 50.00 Crores.

There shall be pre-qualification /post qualification as the case may be, as per existing practice.
