(A) Category "C": New Items.

I. WAB AGENDA of CE (East Zone)

Name of Work: Restoration and Rejuvenation of River Yamuna Flood Plains.

S.H: Development of land between I.T.O Bridge to NH-24, Eastern (Near CWG Village).

The case was presented by CE (East Zone) before Board with the recommendation for acceptance of bid of L1 bidder i.e. **M/s K.R. Anand** at their quoted amount of Rs. 31,03,45,753/- which is (-)27.64% below the justified amount i.e. Rs. Rs.42,88,69,220/- and (-)31.77% below the estimated cost put to tender i.e. Rs.45,48,52,309/- as worked out by CE (East Zone) for the above work.

The A/A &E/S for above said work was accorded vide No. EM6(27)2020/Est./Pt./18114 dated 14.12.2020 for Rs. 74,74,78,138/-.

After due discussion & deliberation, Board agreed with the recommendation of CE(East Zone) and accepted the lowest tender of M/s K.R. Anand at their quoted amount of Rs.31,03,45,753/- which is (-)27.64% below the justified amount i.e. Rs.42,88,69,220/- and (-)31.77% below the estimated cost put to tender i.e. Rs.45,48,52,309/-. Board instructed that CE(East Zone) shall ensure that any deviation in agreement items, extra items/substitute items shall be dealt as per relevant Clauses of the Agreement. He shall also ensure fulfilment of all codal formalities before award of work.
