**Sub:- Revised Financial Powers delegated to officers of Engineering Wing of Delhi Development Authority regarding acceptance/challenge of Arbitration awards.**

Consequent upon the revision of powers in CPWD as per CPWD Works Manual-2014 and in pursuance of approval accorded by Authority as per agenda item no. 67/2018 during its meeting on 14.12.2018, the powers delegated to various officers of DDA have been revised in partial supersession of previous Memorandum of F.5(287)2011-12/PC/DDA/Pt./24 dated 27.01.2012(item no.11). The revised schedule of enhanced delegation of powers regarding acceptance/challenge of Arbitration award is accepted by the Authority vide minutes of meeting no. F2(2)2018/MC/DDA/179 dated 28.12.2018 which is issued with the approval of Vice Chairman, DDA. The enhanced delegation of powers is as under:-
