The 42<sup>nd</sup> EAC (BGDA) committee has approved the revised A/A & E/S of Rs. 632,70,33,610/- (Rs. Six Hundred Thirty-Two Crore, Seventy Lakh, Thirty-Three Thousand Six Hundred and Ten Only) including Work outlay with 3% Contingencies Charges i.e. Rs. 561,79,39,567/- (Rs. Five Hundred Sixty-One Crore, Seventy-Nine Lakh Thirty-Nine Thousand Five Hundred Sixty-Seven Only), departmental charges @ 0.25% i.e. Rs. 1,40,02,402/- (Rs. One Crore Forty Lakhs Two Thousand Four Hundred and Two only) and other charges i.e. Rs. 69,50,91,641/- (Rs. Sixty -Nine Crore, Fifty-Lakh, Ninety- One Thousand, Six Hundred Forty-One Only).

The Chief Engineer (Narela), DDA presented the agenda for above mentioned work in the 42<sup>nd</sup> Estimate Approval Committee (BGDA) meeting held under chairmanship of VC, DDA on 06.10.2023 at 03:30 pm. The minutes of the meeting were circulated vide no. EM3(08)DDA/BGDA/Vol-XL/252 dated: 25/10/2023.

The Finance Member, DDA has accorded the Financial Concurrence to the revised preliminary estimate for the above mentioned work for an amount of Rs. 632,70,33,610/- (Rs. Six Hundred Thirty-Two Crore, Seventy Lakh, Thirty-Three Thousand Six Hundred and Ten Only) including 3% contingencies, Departmental Charges 0.25%, GST Reimbursement, Infrastructure fund & TPQA and conveyed by Sr. Accounts Officer (HAC)/DDA vide No. F.21(2039)/2014-15/HAC/DDA/175 Dated: 22.08.2023 subject to compliance of specific conditions at Sl. No. 1 to 19 of the Financial Concurrence.

The expenditure shall be charged under the head of A/c of "GDA with Major Head 4422 and Minor head 10-A with sufficient budget provisions under the Budget Code-44156302 before carrying out the work.

This accord of revised A/A & E/S is subject to compliance of the specific conditions at Sl. No. 1 to 19 laid down in Financial Concurrence to the RPE with Sanction No. FC-10/2023-24 & subject to the observations mentioned under 42<sup>nd</sup> EAC (BGDA) Minutes of Meeting as well as all other codal formalities and departmental instructions/circular issued time to time.
