BRIEF HISTORY OF THE CASE IS AS UNDER: -

1. The work of construction of boundary wall in Vishal Bagh, Sector, G-2 and G-6 at Narela was awarded to the Claimant i.e. M/S Dharam Vir & Co. vide letter dt.10.11.2010.

2. The stipulated date of start and completion of work was 20.11.2010 and 19.01.2011 respectively. However, due to extra work and the work was actually completed on

17.01.2011.

3. The Claimant approached the EM, DDA office for appointment of arbitrator and Sh. S.K. Jain was appointed as arbitrator on 02.04.2014. Later on EM/DDA has appointed the Sh. S.P. Banwait on dt.03.01.2017.

CE(NZ) was in agreement with the proposed recommendations of EE/NMD-II & SE/NCC-

RECOMMENDATION OF ASB:

ASB in the instant arbitration matter, observed that the award already given by the Ld. Arbitrator Sh. S.P. Banwait has only been set aside by the double bench of Hon'ble High Court vide its order dated 24.12.2024 and no fresh award has been given by the Hon'ble Court. Hence, as such there is no financial burden on the department at this stage. Therefore, after due discussion and deliberation ASB is of the view that the judgement dated 24.12.2024 issued by Hon'ble High Court may not be challenged. However, CE(NZ) has been directed that the concerned Executive Engineer should effectively defend the petition filed by the claimant for appointment of fresh arbitrator in the Hon'ble High Court.

As per revised delegation of power issued vide no. EM1(10)2018/Del. Of Power/DDA/260 dated 29.01.2019 by CE (HQ) DDA, Chief Engineer is the Competent Authority) to accept/challenge in r/o award amount less than 25 lakhs in consultation of ÇAO with due scrutiny by Board Arbitration headed by CE(HQ).
