SANCTION MEMO No. -08

Pursuant to the receipt of in-principle approval of the Competent authority, to the recommendations of the Project Evaluation Committee (PEC) made in its 14th meeting held on 29.07.2024, the PEC is please to accord Administrative Approval and Expenditure Sanction for a total sum of Rs. 14,81,11,540/- (Rupees Fourteen Crore Eighty-One Lakh Eleven Thousand and Five Hundred Forty only) work(s) as per the details is annexed as Annexure-1', under the scheme of DILLI GRAMODAYA ABHIYAN (DGA).

- 1. The works mentioned in the above table, in respect of which the executing agencies are other than DDA, shall be taken as deposit works.
- 2. The expenditure shall be charged/debited under the head of A/c Nazul-I with Major Head 1424 and Minor Head 10 with the Budget Code No. 14600102.
- 3. This Administrative Approvals and Expenditure Sanctions is also subject to compliance of the following:
 - a) The details of approved project shall be uploaded by the executing agencies concerned on the website to avoid duplication of project.
 - b) In case of deposit works, the entire sanctioned amount shall be released as a single installment.
 - c) In such cases where the amount for which the work has been awarded is less than the sanctioned amount, the balance amount shall be surrendered to DDA immediately. In case the amount for which the work has been awarded is more than the sanctioned amount, the work shall be restricted to the sanctioned amount. Any savings accruing after settlement of final bill shall be returned to DDA within 30 days of the settlement.
 - d) No portion of the sanctioned amount shall in any case be used for meeting land acquisition cost or for meeting any revenue expenditure such as O & M expenditure, Salaries & allowances, establishment cost, etc.
 - e) In order to ensure the quality work, stringent provisions shall be included by the respective Executing Agencies in the tender documents. No arbitration clause shall be applicable for any work executed under DGA.
 - f) The executing agency may explore floating a single tender for similar work, for attracting good contractor and faster execution of work.

- g) The sanctioned amount can be used only for purchase of materials/equipment needed for the operation of the project. The funds will not be used to meet recurring expenditure, purchase of vehicle of any kind, organizing fairs, expenditure on any work within religious premises, purchase of office and IT equipment, consumables, etc.
- h) No portion of the sanctioned amount shall in any case be utilized as grant-in-aid.
- Executing agency shall submit the year- wise utilization certificate and completion certificates for sanctioned work in the format as prescribed by the PEC.
- j) To avoid delays in the execution of work(s) as per fixed time schedule(s), the Executing agency shall obtain all required approval / NOC from the concerned department well in advance, if necessary.
- k) The test check of the works shall be carried out as per the provisions of the CPWD manual.
- The Executing Agency shall submit monthly and quarterly physical & financial progress to the PEC in such manner and format as prescribed by the PEC.
- m) All works shall be subjected to third party quality assurance, audit, provisioning for which shall be made in the N.I.T. by Executing Agency.
- n) All works undertaken under this scheme shall be geo-tagged.
- All mandatory approvals and drawings are to be sought by the Technical Sanction authority wherever required.
- p) The work should be executed in accordance with the approved estimate(s) only through proper call of tenders after completing all the codal formalities.
- q) Utmost economy in expenditure shall be ensured by the executing agency.
- r) The Technical Sanction Authority shall ensure that all provision of CPWD Manual and relevant provisions of the General Financial Rules as applicable are duly complied with.
- s) It shall be ensured by the executing agency that Extra/Substitute items, if necessarily required shall be approved within the sanctioned amount and that no undue benefit accrues to the executing agency.
- t) All the payments should be made on regular bills/vouchers duly entered in the e-measurement book(s)/measurement book(s). The work should be completed as per fixed time schedule(s).
- u) The revision of estimate(s)/sanction(s) is not allowed.
- v) The department responsible to execute the work shall be responsible to ensure enforcement of Labour Welfare, QAC, AGCR Audit, Vigilance check and other necessary checks as applicable, from time to time.
