Engineer Member, DDA has been pleased to accord Financial concurrence to the Preliminary Estimate amounting to Rs. 2,88,37,191 (Rs. Two Crore Eighty Eight Lacs Thirty Seven Thousand One Hundred and Ninety One only) i/c 3% Contingency and 11.25% Departmental Charges as been submitted by CE (Sports) as under:

Total Works outlay i/c 3% Contingencies : Rs. 2,59,21,071

Department Charges @ 11.25% on Works outlay : Rs. 29,16,120

Total : Rs. 2,88,37,191

(Rs. Two Crore Eighty Eight Lacs Thirty Seven Thousand One Hundred and Ninety One only)

The above Financial Concurrence will be subject to the following conditions:

1. Technical Correctness of item, units, quality, quantity, rates and amount shall be with the EE(Co-ordn.)/EM/DDA's office & also authority who would accord Technical sanction to the proposal at the time of call of tenders. The correctness of the estimate may thoroughly be examined by the Technical sanctioning authority before making any payment.
2. Utmost economy in expenditure shall however be ensured by Engineering Wing during execution of work.
3. Prior clearance and approval of design from various civic agencies be ascertained before call of tenders so that the work is executed without hindrance.
4. The sanction authority of deviation will invariably ensure that there is no undue benefit should accrue to the contractor
5. The land available is free from all hindrances.
6. No work is to be executed and liability incurred before the A/A & E/S accorded by the competent authority.
7. Provision kept in PE for different sub heads will not be misused/diverted in other sub Heads.
8. No payment shall be released unless the AA&ES is accorded to the above extent.
9. Expenditure in r/o Electrical/Horticulture be subject to approval of Technical sanction authority of Electrical/Horticulture respectively.
10. The rates so allowed for additional quantities/items should be lowest as per market trend.

1. Utmost care is to be taken classification of expenditure on this upgradation. This must be classified as per the CPWD Manual and CPWA code since structures for similar purposes and uses already exists. Cost of material disposed off is also to be accounted for as per the guidelines and to be credited to the relevant head of account.
12. There should be no deviation in the scope of work. In case, the cost of work exceeds Rs. 5.00 Crores (Rupees Five Crores) approval of authority competent be obtained as the work would fall beyond the financial power of EM/DDA in that eventuality.

It must be ensured by the concerned engineers that the scope of work mentioned in the PE shall be strictly followed and there should be no deviation in the scope of work.
