| (ii) | From 16 th day till 30 th day from the date of issue of demand cum allotment letter | 10% of the Application Money. |
| (iii) | From 31 st day till 90 th day from the date of issue of demand cum allotment letter | 50% of the Application Money. |
| (iv) | 91 st day onwards from the date of issue of demand cum allotment letter | Full Application Money. |

The Public Notice is being issued to this effect.


