I. GENERAL INSTRUCTIONS TO BIDDER/LICENSEES/PROSPECTIVE BIDDER/LICENSEES

- Only registered bidder/licensees, who are eligible and have paid Earnest Money Deposit online, will be able to participate in this e-auction.
 - i) The accepting authority of e-auction i.e. Member (Admin & LM), DDA may withdraw any kiosk without assigning any reason from the e-auction at any stage.
 - ii) While finalizing the e-auctions, the accepting authority i.e. the Vice Chairman, Delhi Development Authority may also at his discretion, form a panel (waiting list) from among the bidder/licensees in accordance with the amount e-auctioned by them. In case of failure of the successful bidder/licensee to comply with the terms & conditions of the e-auction leading to cancellation of his e-auction bid or contract, as the case may be, Vice Chairman, DDA would be well within his right to allot the site to the next highest auctioner/bidder/licensee on the panel on the rates as quoted by the first successful auctioner, instead of re-e-auctioning it. The decision of accepting authority shall be final and binding on the participants of the e-auction.
- 3. **Format and Signing of Proposal:** Bidder/licensees would provide all the information as per this E-Auction Document and in the specified formats. DDA reserves the right to reject any Proposal that is not in the specified formats.
- 4. **Proposal Preparation Cost:** The Bidder/licensee shall be responsible for all the costs associated with the preparation of his Proposal and participation in the bidding process. DDA will not be responsible or in any way liable for such costs, regardless of the conduct or outcome of bidding.
- 5. **Language and Currency:** The Proposal and all related correspondence and documents shall be written in the English language. The currency for the purpose of the Proposal shall be the Indian Rupee (INR).
- 6. **Cost of E-Auction Document:** The bidder/licensees have to download e-Auction Documents from DDA website www.dda.gov.in or e-auction website www.ddaeauction.co.in free of cost.
- 7. **Validity of Proposal:** The Proposal shall remain valid for a period of 180 days from the date of e-bidding. Prior to expiry of the original Proposal Validity Period, DDA may request the Bidder/licensees to extend the period of validity for a specified additional period. A Bidder/licensee may refuse the request without forfeiting its Bid Security. A Bidder/licensee agreeing to the request will not be allowed-to modify its Proposal but would be required to extend the validity of its EMD Deposit for the period of extension. - 8. **Clarifications:** To assist in the process of evaluation of Proposals, DDA may, at its sole discretion, ask any Bidder/licensee for clarification on its Proposal. The request for clarification and the response shall be in writing or by facsimile. No change in the substance of the Proposal would be permitted by way of such clarifications.
- 9. **Amendment of E-Auction Document:** At any time prior to the Proposal Due Date, DDA may, for any reason, whether at its own initiative or in response to clarifications requested by a Bidder/licensee, modify the E-Auction Document. Any modification thus issued will be informed to all the prospective bidder/licensees by notifying on DDA website as well as e- auction website. Such modification will be binding upon all bidder/licensees participating in E- Auction process.
- 10. **Confidentiality:** Information relating to the e-auction process shall not be disclosed to any person not officially concerned with the process. DDA will treat all information submitted as part of Proposal in confidence and will not divulge any such information unless it is ordered to do so by any authority that has the power under law to require its disclosure.
- 11. **DDA's Right to Accept or Reject Proposal:** DDA reserves the right to accept or reject any or all of the Proposals/e-bids without assigning any reason whatsoever and to take any measure as it may deem fit, including annulment of the bidding process, at any time prior to award of Project, without liability or any obligation for such acceptance, rejection or annulment.
- 12. **Force Majeure:** The bidder/licensees shall not be responsible for failure or delay in performing their obligations under presents due to force majeure, which shall include natural calamities including epidemic, lightning, earthquake, flood, storm, or other unusual or extreme adverse weather or environmental conditions. If the circumstances leading to force majeure occur, the affected party shall give notice thereof to the other party i.e. DDA. The notice shall include full particulars of the nature of Force Majeure event, the effect it is likely to have on the Affected Party's performance of its obligations and the measures which the Affected Party is taking, or proposes to take, to alleviate the impact of the Force Majeure Event and restore the performance of its obligations. II. BRIEF SCOPE OF WORK

1. This e-auction offers kiosks in green-area owned and controlled by DDA in various parts of Delhi, as per the details at **Annexure 1**. The sites will be allotted on license through e-auction to the Page 6 of 32

successful (H1) bidder/licensee who bids highest value of license fee which shall be paid on monthly basis. Each site will be separately auctioned. A bidder/licensee can bid for any number of sites, subject to submitting separate EMD amount for each of the site for which he bids. EMD amount for each of the site is mentioned in Annexure-1 & 2 of this document.

- The kiosks can be used by the licensee only for general purpose.
- 3. Buffer Area: Open space around any particular property- kiosk that is required to be used along with the property under question, will be marked and defined individually by Assistant Director of concerned Horticulture Department and approved by Deputy Director of the concerned Horticulture Department based on the existing physical structures, space requirement and kiosk design. In no circumstance, would the open space on any side of the kiosk be more than 3.0 meters in width.

The open space around kiosk property would be clearly marked by series of planters and seaters, on the basis of the approved Landscape drawing, in such a manner that the visual and physical connectivity of the open space attached with the kiosk and the remaining of the park is maintained. In no circumstance, shall the total area of this spill out open space amount to twice the covered area of the property. This arrangement of attached open space is subject to land being under the jurisdiction of DDA.

4. The kiosks will be given on license to the highest bidder/licensee/licensee (H1 bidder/licensee) for a period of **five years** subject to 10% increase after every year and the license agreement of the kiosks shall be initially **signed for a period of one year only**, which is renewable on completion of one year subject to satisfactory performance as certified by the concerned Deputy Director (Horticulture) on the recommendation of the concerned Section Officer (Horticulture) and clearance of all dues. Bidder/licensees can also opt out after one year instead of asking for renewal at his discretion. The process of renewal of the contract shall start in the first week of the 10thmonth of the ongoing license period after receipt of a written request for renewal from the licensee to Deputy Director (License Property Cell) and the request will be approved subject to the recommendation of the concerned Deputy Director (Horticulture).

III. E-AUCTION DETAILS FOR PRESENT PROJECT

- 1. Eligibility: The participants in e-auction shall be individual or companies.
- 2. **Earnest Money Deposit:** To be able to participate in e-auction for a particular kiosk, the prescribed Earnest Money Deposit (specified in Annexure-1 & 2, separately for each site) equal to three times the amount of reserve price for that site is to be paid by the bidder/licensee through online mechanism of e-auction portal www.ddaeauction.co.in. Detailed instructions to guide the

bidder/licensee through the e-payment, steps are available on the said portal/website. EMD will be treated as a Security Deposit in the Department which may be adjusted against the license fee for the last three months of the license period. The aforesaid earnest money shall always be interest free.

The EMD of the unsuccessful bidder/licensee will be refunded electronically to their bank account after the completion of auction, without interest generally in 15 days.

- 3. Individual Bidding per Site: One bidder/licensee may participate in e-auction for any number/all the kiosks with separate prescribed EMD, and can be 'H1 bidder/licensee' for any number of kiosks.
- 4. Payment to be made within 7 days of the date of bidding (2nd Stage EMD): After the successful bidding, the H1 bidder/licensee will have to deposit 3 times the H1 bid amount minus the EMD, through online e-payment gateway of BHOOMI Portal. If bidder fails to make this payment, his bid will be cancelled and EMD deposited earlier will be forfeited.

Illustration:

- The reserve price for a site is Rs. 20,000 and the EMD is Rs.60, 000 /-.
- The highest bidder/licensee/licensee bids Rs.40, 000 /- (monthly license fee)
- The bidder/licensee has to make payment of 3 X 40,000 –60,000 = Rs. 60,000 /-. Accordingly, the bidder/licensee shall have to deposit Rs. 60,000 /- within 7 days of the date of online e-bidding.
- 5. **Performance Security:** H1 bidder/licensee is required to submit 6 months license fee in advance as Performance Security before possession as per Allotment Letter. The Demand-cum-Allotment Letter would be issued to the successful bidder from the BHOOMI Portal after receipt of 2nd stage EMD payment and other requisite documents and verification of the second stage EMD.
- Prospective bidder/licensees shall ensure the following before participating in e-auction:
 - a) Participants have to get themselves registered on the e-auction portal i.e. www.ddaeauction.co.in by making online payment for Rs. 2000 + GST. Help is provided to the prospective bidder/licensees for registration at DDA Help Desk, Vikas Sadan, INA, New Delhi and at the Tender Wizard Helpdesk, Unit no. 202-203, 2nd floor H.B.  - b) Participants shall have a valid class III Digital Signature Certificate (DSC) issued by any of the certifying authority. Help is provided to prospective bidder/licensees for procuring digital signatures at the help desks mentioned at (a) above, if they so desire.

- c) Participants shall safely keep their User ID and password, which will be issued by the online service provider upon registration, and which is necessary for e-bidding.
- d) Bidder/licensees are advised to change the password immediately on receipt from the e- auctioning portal.
- e) Bidder/licensees shall not disclose their User ID as well as password and other material information relating to the bidding to any one and safeguard its secrecy.
- f) Vendors should not use the same generated NEFT challan for multiple payments.
- g) Vendors should make only one single payment for the respective auctions and do not use multiple payments for the same auction.
- h) Vendors should update the correct Account Number details in their profile for Refund process. If any discrepancy in the account number, Refund transactions will get reject and it takes around 10-15 days to get refund.

7. Online bids:

- a) The bidder/licensees are required to quote for the rate (monthly license fee) with reference to the property (kiosks) put on e-auction, over and above the reserve price mentioned in the Annexures 1 & 2.
- b) E-auction will start and end as per schedule mentioned in offer document. The bid for e-auction shall start with minimum one increment above the reserve price. Increment of rate in e-auction shall be Rs. 1,000/- (minimum increment value) or multiple thereof.
- c) Once the e-bid is placed, the bidder/licensee cannot reduce or withdraw it for whatever reason. If done so, the EMD amount shall be forfeited.
- d) The bidder/licensee shall be solely responsible for all consequences arising out of the bid submitted by him/her (including any wrongful bidding) and no complaint/representation will be entertained in this regard by the DDA/Service provider. Hence bidder/licensees are cautioned to be careful to check the bid amount, and alter/rectify their bid amount if required, before submitting the bid.
- 8. If any market leading bid (bid higher than the highest at the point in time) is received within the last ten (10) minutes of closing time, the time of auction sale will get automatically extended by another ten (10) minutes and subsequently, if no further bid higher than the last quoted highest bid is received within the said extended ten minutes, the auction sale will be automatically closed at the expiry of the extended ten (10) minutes.

9. Training and Assistance Booth for the prospective Bidder/licensees

For facility of the prospective bidder/licensees, a Helpdesk has been set up at Nagrik Suvidha Kendra, DDA Office, D-Block, Vikas Sadan, INA, New Delhi-23. Prospective bidder/licensees can get the required training and information on e-auctioning process during working hours.

Note of caution for the Bidder/licensees:

- i) Bidder/licensees may encounter certain unforeseen problems such as time lag, heavy traffic, and system/power failure at the Bidder/licensees end. To avoid losing out on bidding because of above- mentioned reasons, it is advised to have reliable internet connection and Information and Communication Technology (ICT) equipment and not to wait for the last moment for submitting your bid.
- ii) The Bidder/licensee is expected to carefully examine all the instructions, guidelines, terms and conditions and formats of the E-Auction. Failure to furnish all the necessary information as required or submission of a proposal not substantially responsive to all the requirements of the E-Auction shall be at Bidder/licensee's own risk and may be liable for rejection.

11. UNCONDITIONAL BIDS -

Bidder/licensees may note that DDA will not entertain any deviations from the E-Auction Document at the time of submission of the Proposal or thereafter. The Proposal to besubmitted by the Bidder/licensees will be unconditional and unqualified and the Bidder/licensees would be deemed to have accepted the terms and conditions of the E-Auction Document with all its contents including the Draft Service Agreement. Any conditional proposal shall be regarded as non-responsive and would be liable for rejection.

12. REJECTION OF BIDS -

DDA reserves the right to reject any/all bids without assigning any reason thereof and without incurring any liability to the affected bidder/licensee(s) or any obligation to inform the affected bidder/licensee(s) of the grounds for such decision. The DDA may at its sole discretion and atany time during the evaluation of Proposal, disqualify any Bidder/licensee, if the Bidder/licensee has:

- i. Made misleading or false representations in the E-Auction reply or documents in support of mandatory criteria.
- ii. Submitted a proposal online that is not accompanied by required documentation or is non-responsive. In the absence of any document as required, the concerned party shall be considered as not eligible and in that eventuality their participation in the e-Auction shall not be considered.

- iii. Failed to provide clarifications related thereto, when sought;
- iv. Disclosed information relating to the examination, clarification and comparison of the Proposals to any bidder/licensee or any other person(s) not officially concerned with such process until the selection process is over. The undue use by any Bidder/licensee of confidential information related to the process may result in rejection of their bid.
- v. Submitted any superfluous document(s) not related to the mandatory criteria. All participating bidder/licensees are clearly instructed to attach only those documents which are relevant to the scope of work/mandatory criteria as specified in the E-Auction document.
- vi. Indulged in malicious campaign or disinformation campaign against any official of the DDA or any other bidder/licensees either directly or through third parties.

Any of the above defaults shall make the bidder/licensee liable for rejection of bid and for other legal actions as per law. Such bidder/licensee may also be blacklisted by the DDA.

- 13. **BIDDER/LICENSEE'S RESPONSIBILITY** The following due diligence/deliberation is the sole responsibility of the bidder/licensee:
 - The Bidder/licensee may carry out field visit to assess the site offered on license at any time at his own cost. This is very important, as the sites are offered on 'AS IS WHERE IS' basis.
 - ii. The Bidder/licensee is expected to examine carefully the contents of all the documents provided. Failure to comply with the requirements of E-Auction Document will be at the Bidder/licensee's own risk.
 - iii. It would be deemed that prior to the submission of Proposal, the Bidder/licensee has:
 - Made a complete and careful examination of requirements, and other information set forth in this E-Auction Document;
 - (ii) Received all such relevant information as it has requested from DDA.
 - (iii) Made a complete and careful examination of the various aspects of the Project that might affect the Bidder/licensee's performance under the terms of this E-Auction Document.

DDA shall not be liable for any mistake or error or neglect by the Bidder/licensee in respect of any of the above.

IV. RIGHTS AND RESPONSIBILITIES OF LICENSEE AND DDA

Nature of Usage Allowed By DDA:

- The licensed kiosks shall not be used or permitted to be used for any other purpose, whatsoever except general use for which authorization has been issued.
- ii. The kiosks are being e-auctioned on "As is where is" Basis. It is presumed that the intending auctioner has inspected the kiosks and familiarized himself/herself with the prevailing conditions in all respect before participating in the e-auction. No claim/dispute regarding condition/capacity of the kiosks shall be entertained by DDA. The auctioner cannot put any condition with his/her e- auction.
- iii. The bidder/licensee shall be responsible for maintenance of sanitation, safety and security of site.
- iv. The Licensee shall maintain the kiosk in proper & sound condition. The lighting of the kiosk shall be get done by Licensee at his/her own cost.
- v. At his own cost and expenses, licensee shall install as many C.C.T.V cameras as are required. The C.C.T.V cameras shall always be kept in working condition.
- vi. The licensee shall not display or exhibit any pictures, poster, statues or other articles, except the instructions of DDA.
- vii. Construction of any permanent, temporary structure, seating arrangement by licensee will not be allowed in buffer area. However, the space can only be used as loading and unloading area, placing movable signage and dustbins during working hours of kiosk
- viii. The licensee shall not display or exhibit any advertisements or place or put up a hoarding on any part of the interior or exterior of the kiosks.
- ix. No criminal case or moral turpitude shall be pending against the prospective bidder/licensee.
- x. The licensee will quit the site peacefully after the expiry of license or on its cancellation.
- xi. The auctioner/licensee shall abide by all the rules and by-laws of the DDA and other authorities in the matter of running the business and keeping the site in proper

- condition. He shall also pay all municipal taxes or fees i.e. property tax, electricity and water charges for carrying on the work.
- xii. The auctioner/licensee shall not object to any construction/alteration in or around the allotted premises that is considered essential by DDA.
- xiii. The auctioner/licensee shall be liable for any damage/loss and theft. DDA will not be a party to any dispute between licensee and third party.
- xiv. That the licensee shall not be entitled to allow any other person to use the premises in his place or to use any part thereof. In the event of the death of licensee, or the licensee becoming insolvent, or dissolved if it is a partnership firm prior to the expiry of the period fixed hereinafter, the licence shall stand terminated automatically andthe legal representatives of the licensee shall not be entitled to use the premises. However, with the express approval of the licensor in writing, the legal heirs or representatives may be permitted after discharging any liability that the licensee may have incurred, remove the goods and other equipment that may be found at the licensee premises. But in the case goods are not claimed by the legal heirs/representatives within four weeks of the demise of the licensee, the licensormay, by public auction dispose of the same.
- xv. That the dealing of the licensee/his employees with the public, officials/officers shall be polite and courteous, and he shall not indulge in or suffer any anti-social activity. The licensee shall also not indulge in any activity which may cause harm to the interest of Delhi Development Authority or its employees.
- xvi. That if the licensee allows credit, he will do so at his own risk and the licensor will take no obligation whatsoever in this regard and no request or claim from the licensee shall be entertained on this account.
- xvii. Firefighting arrangements should be made at the site by the licensee at his own cost to avoid any mishappening.
 - xviii. The licensee will be granted two months' time for obtaining electricity and water connection. In this period of two months, the licensee will also complete his fitting/set up etc. inside the kiosk in order to make the kioskoperational. "The property is being offered on 'as is where is' basis. Wherever electricity/water connection is not provided, such arrangement shall be made by the licensee at his own cost. DDA shall not be responsible and will stand indemnified if the bidder is not able to get water/electricity due to any reason whatsoever. Further, wherever

On D.A. sewer connection is not provided, no wet kitchen is allowed and only dry kitchen with ready to serve food/packed food items can be operated."

xix. The licensee shall be responsible of electricity and water charges to respective agency and DDA shall remain indemnified. If the licensee is unable to obtain the requisite connection such as electricity, water, etc. due to reasons beyond his control, these facilities are not provided within two months, then permission for another two months will be granted by Commissioner (Land Department) based on merit of each case. In case of any exceptional circumstance, where the delay in obtaining the requisite connection such as electricity, water, drainage, sewer etc. due to reasons beyond his control, then Member (Admin & LM) will be competent to grant extension beyond period of 4 months on case to case basis.

2. Other Obligations of Licensee

- The bidder/licensee/licensee shall have to abide by all the relevant directions of DDA, Orders/Directions of the Courts of law related to such sites in question in addition to the terms of this E-Auction.
- ii. The bidder/licensee/licensee shall be responsible for all statutory taxes and payments to different agencies and indemnify DDA from the same.
- iii. The bidder/licensee/licensee shall also absolutely comply with all the extant laws as applicable to the Government of NCT of Delhi/UOI etc.
- iv. Proper Cleanliness should be maintained by the licensee and arrangement be made for solid and liquid waste disposal separately in co-ordination with the concerned local bodies/MCDs and will also abide by Swachh Bharat Mission rules notified in this regard and various directions issued by various Authorites from time to time. He shall ensure that no waste shall be unauthorizedly dumped/discharged in violation of above rule.

3. Site Termination by DDA prior to end of contract period:

- DDA at any time may take back the physical possession of the site, if the site is required for any development project with the approval of competent authority.

3.1 Subject to and in accordance with the terms and covenants set forth in this Agreement, DDA hereby grants and authorizes the Service Provider to finance, establish, operate and maintain the Project and to exercise and/or enjoy the rights, powers, benefits, privileges, authorizations and entitlements as per the E-Auction terms and conditions. However, the service provider shallhave no right title or interest of any kind except the permission to use the allocated sites for permissible purposes during the validity of agreement and for the specified period mentioned in this agreement.

4. PROJECT PERIOD

4.1 As per E-Auction clause II (3), subject to the terms and conditions.

5. SERVICE PROVIDER'S OBLIGATIONS

- 5.1 The Public Service Provider shall be responsible for the entire scope of workas in e-Auction Documents as well as the following:

8. NO BREACH OF OBLIGATIONS

FORCE MAJEURE

9.1 Force Majeure Event: The bidder/licensees shall not be responsible for failure or delay in performing their obligations under presents due to force majeure, whichshall include natural calamities including Act of God, epidemic, lightning, earthquake, cyclone, whirlwind, flood, tempest, storm, and drought, lack of water or other unusual or extreme adverse weather or environmental conditions. If the circumstances leading to force majeure occur, the affected party shall give notice thereof to the other party i.e. DDA. The notice shall include full particulars of the nature of Force Majeure event, the effect it is likely to have on the Affected Party's performance of its obligations and the measures which the Affected Partyis taking, or proposes to take, to alleviate the impact of the Force Majeure Eventand restore the performance of its obligations. - **13.1 Governing Law and Jurisdiction:** This Agreement shall be governed by thelaws of India. The Courts at Delhi shall have jurisdiction over all matters arising out of or relating to this Agreement.
