**CNG STATION SITES ON 'AS IS WHERE IS' BASIS**  
**ON LICENSE FEE BASIS**

**All prospective bidders are hereby informed that the following Paras /Clauses of the Tender Document for E-Auction (2021-2022) of CNG Station Sites on 'As is Where is' Basis on License Fee Basis have been added. The same may please be read as under:-**

2.4.8.A. Certain LoI holder of M/s IGL have approached Hon'ble High Court, wherein, Hon'ble High Court vide Order dated 22.09.2021 in W.P.(C)6984/2021 CM APPL. 22062/2021 and other similar connected matters has granted temporary injunction (T.I.) against M/s IGL, that no third party interest shall be created by M/s IGL till the disposal of the Writ Petitions (W.P.).

2.4.8.B. In view of above T.I., bidders may participate in the Auction process subject to outcome of the W.P. In case, the H1 bidder is unable to obtain LoI from M/s IGL due to continuation of T.I. on the site, the time period during which the said T.I. is in force shall be deducted in calculation of 90 days (in clause 2.4.6) or additional 275 days ( in clause 2.4.7). No interest/ penalty would be payable for the period during which T.I is in force, and the bidder's case is affected by the said T.I.

2.4.8.C. In case T.I. continues for more than 180 days (from the date of intimation of acceptance of bid), DDA shall have discretion to cancel the LoI issued by DDA, and refund the EMD in full. Similarly, in such cases, the H1 bidder may opt for withdrawal from the bidding process, and in that case full EMD will be refunded after deducting Rs 10,000/- as processing charges.

All remaining terms and conditions of the tender document and its corrigendum(s) shall remain the same.
