- g) Any other grounds deemed appropriate wherein refunds arise.
- The above delegation shall also apply in cases of court-directed payments, including penalty and litigation charges. The concerned branch will process the cases as per the delegation
- This circular is applicable exclusively to cases under the Land Disposal Department. All codal formalities required for processing refunds such as verification of payments, bank details, etc. must be strictly adhered to in accordance with the prevailing DDA guidelines.
