(ii) These Regulations shall come into force with effect from the dates of its approval by the Delhi Development Authority

3. Disqualification .- No person-

(a) Who has entered into or contracted a marriage with a person having a spouse living, or

(b) Who having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post:

Provided that Authority may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for go doing, exempt any person from the operation of this rule.

4. Power to Relax .- Where the Lt. Governor, Delhi is of the opinion that it is necessary or expedient to do, it may
