## NOTIFICATION

New Delhi, the 23rd February, 2000

G.S.R. 155(I).—In exercise of the powers conferred by Section 57 of the Delhi Development Act, 1957 (61 of 1957), read with sub-rule (1) of rule 3 of the Delhi Development (Miscellaneous) Rules 1959, the Delhi Development Authority, hereby makes, with the previous approval of the Central Government, the following Regulations relating to the methods of recruitment to the posts of Librarian/Asstt. Librarian which may be read as under :

## Recruitment Regulations for the post of Librarian in DDA

5. Age	35 years (relaxation of 5 years to the Central Govt./ State Govt/DDA employees under the orders of Central Govt.)

Educational/Qualification	<p>Essential :</p> <ul style="list-style-type: none"> <li>(i) Masters degree or graduation with Hons. degree of a recognised University with Hindi or English as a Subject.</li> <li>(ii) Degree or Diploma in Library Science of a recognised University/Institution.</li> <li>(iii) 3 years administrative and organising experience in a library of standing.</li> <li>(iv) Knowledge of technique of book preservation.</li> <li>(v) Diploma in Public Relations/Journalism.</li> </ul> <p>Desirable :</p> <ul style="list-style-type: none"> <li>(i) Proficiency in a language other than the one at graduation level.</li> <li>(ii) For departmental candidates the post will be regularised only when Diploma in Journalism/PR is acquired by the promotee.</li> </ul>

11. Whether age and qualifications prescribed for direct recruits will apply in the case of promotion.	Not applicable
12. Savings.	Nothing in these regulations shall effect reservations, relaxation of age limit and other concessions required to be provided for the SC/ST, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Govt/DDA from time to time.
13. Disqualification	<p>Who has entered into or contracted marriage with a person having a spouse living or</p>

## 14. Powers to relax

- (b) Who having a spouse living has entered into or contracted a marriage with any person, shall not be eligible for appointment to the said post.
- Provided that the Central Govt./DDA may, satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this regulation.

- Where the Chairman/Authority is of the opinion that it is necessary or expedient so to do, it may be order, for reason to be recorded in writing relax any of the provisions of these regulations in respect of any class or category of persons or post.

## 11. Disqualification

- No person
- (a) Who has entered into or contracted marriage with a person having a spouse living or;
- (b) Who having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.
