

2. The above *ad hoc* promotion is subject to the condition that, if any Account Officer who is on deputation joins back to DDA the junior most Account officer will be reverted back to the post of Assistant Account Officer.

No financial benefits shall be allowed to above named officers, if they had already been granted benefit of financial upgradation under ACP/MACP Scheme in Level-9 (Rs. 53,100 – 1,67,800/-) of Pay Matrix as per 7<sup>th</sup> CPC [Pre-revised Pay Band of Rs. 9300-34800 with Grade Pay of Rs.5400/- (6<sup>th</sup> CPC)]. If not granted, their pay will be fixed under the provisions of FR.22(I)(a)(1). However, option for fixation of pay from the date of increment in the lower grade will not be admissible.

4. They are directed to submit their joining report to Director (Pers.)-1 for further place of postng. Their promotion will be effective from the date of their joining on the post of Account Officer.


