ESTABLISHMENT ORDER

On the recommendations of Senior Level Departmental Promotion Committee (Group 'A' Officers), Vice-Chairman, DDA is pleased to promote Sh. Anand Kumar S/o Sh. Lal Babu Chaudhary, (UID-0613001), Dy. Director (Planning) to the post of Director (Planning) on *ad-hoc* basis in Level-12 (Rs. 78,800-209200/-) of Pay Matrix as per 7th C.P.C. [Pre-revised Pay Band-3 of Rs.15600-39100/- with Grade Pay of Rs.7600/- as per 6th CPC]. These orders will be effective from 01.01.2025.

2. This *ad-hoc* promotion is subject to the final outcome in the SLP being filed by CBI in the Hon'ble Supreme Court of India against the judgment dated 05.05.2023 of the High Court of Jharkhand at Ranchi in Cr. M.P No. 2857 of 2013 titled Durganand Minz v. State of Jharkhand through CBI (related to case FIR No. RC 03(A)/2011-R) and if the decision of the SLP in r/o Sh. Durganand Minz, Dy. Dir.(Plg.) comes in favour of Sh. Minz and he becomes eligible for promotion to the post of Dir.(Plg.) or Sh. Banoth Jeevan Babu, Director (Plg.) who is on deputation joins back DDA, then the junior most Director (Planning) will be reverted to the post of Dy. Dir.(Plg.).

3. The above *ad hoc* promotion is further subject to the recommendations of Review DPCs, being conducted in compliance of Hon'ble High Court of Delhi's Order dated 30.09.2019, and also subject to the final outcome in SLP (C) bearing No.026494/2019 titled Ashok Kumar Vs Kanwal Kumar and Ors. & SLP (C) No.001762/2020 titled Nidhi Tyagi Vs Kanwal Kumar and Ors. pending before the Hon'ble Supreme Court of India.

4. No financial benefit shall be allowed to above named officer, if he had already been granted benefit of financial upgradation under ACP or MACP Scheme in Level-12 (Rs.78,800 - 2,09,200/-) of Pay Matrix as per 7th CPC [Pre-revised Pay Band-3 of Rs.15600-39100/- with Grade Pay of Rs.7600/- as per 6th CPC] otherwise, his pay will be fixed under the provisions of FR.22(I)(a)(1). However the option for fixation of pay from the date of increment in the lower grade will not be admissible to him.

5. Sh. Anand Kumar is directed to report to Commissioner (Personnel), DDA for further posting and a copy of the joining may also be forwarded to Dy. Director (P)-I. The promotion will be effective from the date of his joining to the post of Director (Planning).

6. The above promotion is *provisional and subject to outcome of pending Contempt Petition No. 314/2016 and SLP (C) No. 4831/2012 before Hon'ble Supreme Court.*
