Subject: Grant of Non-Functional Selection Grade (a segment of JAG & Non functional) in Level-13 of the pay matrix to the Group 'A' Officers of DDA – reg.

In reference to the decisions taken by the 'Authority' vide Resolution No. 3 dated 12.03.1992, Resolution No.110/93, Resolution No. 125/96 dated 27.08.1996 and Resolution No. 65/2010 dated 14.05.2010 read with E.O. No. 2863 dated 09.09.1992 & E.O. No. 3584 dated 09.09.1993 and in pursuance of the approval of Hon'ble Lt. Governor, Delhi/Chairman, DDA to implement the provisions, *mutatis mutandis*, envisaged in para 2(c)(i) & (ii) of the Office Memorandum No. DoPT-1671777510047 dated 21.12.2022 issued by DoP&T, the scheme of placement of the Group 'A' Officers of DDA in NFSG (except officers of Engineering Cadres of DDA) is further supplemented as under: -

(i) The officers of DDA, who have entered the concerned cadre through promotion in accordance with the provisions in Recruitment Rules at the Junior Time Scale (Level-10 in pay matrix) of that cadre and hold the post at JAG level (Level-12) shall be considered for placement in Non-Functional Selection Grade (Level-13 in pay matrix) based on the seniority inter-alia subject to the condition that such officers have completed combined regular service of 13 years calculated from the year of promotion to Group 'A' on the date of consideration for NFSG.

(ii) In case of officers directly recruited (or directly promoted from Group 'B') at Senior Time Scale (Level-11) in that cadre under the provisions of Recruitment Rules, placement of such officers in NFSG will be considered only after holding of post at JAG level and after completion of 9 years of combined regular service in STS and JAG level posts.


(iii) For officers directly recruited at JTS Level Group 'A' post, the existing provisions will remain unchanged.


2. The provisions mentioned in sub-para (i) and (ii) above shall be effective from 21.12.2022 being the date of issue of aforesaid DoPT's OM i.e. 21.12.2022.

3. Except as above and other decisions already taken by the 'Authority', the other conditions and procedure/criteria for Selection Committee as issued by DoPT from time to time for placement in the JAG-NFSG will remain unchanged.
