## CIRCULAR NO: 49 /2024

A Limited Departmental Competitive Examination (LDCE) for promotion from Senior Secretariat Assistant(SSA) to Assistant Section Officer(ASO) in the Level-7 of pay matrix as per 7th CPC (Grade Pay of Rs. 4600/-) (PB-2 of Rs. 9300 – 34800) is proposed to be held shortly.

- 2. The Senior Secretariat Assistants (SSAs/UDCs) having completed 03 years' regular service as on 01.01.2023, 01.01.2024 and 01.01.2025 are eligible to appear in the written exam for the post of Assistant Section officer.
- 4. The Applications should be forwarded through proper channel to the office of Dy. Director (P)-III, DDA, B-Block, 3<sup>rd</sup> Floor, Room No-316, INA, Vikas Sadan, New Delhi latest by 05:00 PM on 24.12.2024 as per the following guidelines: -
  - a. The complete filled Application Form duly forwarded through his/her concerned Branch Officer who will verify the details given in the Pro-forma (Annexure-1).
  - Three recent colour passport size photographs (one photograph pasted on form duly attested by the concerned Controlling Officer and two photographs unattested).
  - c. The SC/ST applicant should also submit the self-attested photocopy of the caste certificate.
  - d. The PwBD applicant should also submit the self-attested photocopy of the certificate.
  - Applications having incomplete particulars or received after the due date and time shall not be entertained.
- 5. The schedule of Pre-Promotional Training/Computer Training will be notified separately. The syllabus for the above exam is enclosed herewith (Annexure-II).
- 6. SC/ST candidate will be eligible for relaxation of 20 marks. This relaxation will cover not only the passing marks to be given in aggregate but will be inclusive of the passing marks given in each individual paper so that the total number of marks covered by such relaxation shall not exceed 20 marks.
- 7 The PwBD candidate will be eligible for the same relaxation as applicable for the SC/ST candidate.
- 8. This may be treated as Notice of the Limited Departmental Competitive Examination for the post of Assistant Section Officer and the date of the said examination will be intimated later on a short notice.
- 9. Further, this examination will be conducted along with the LDCE already notified vide Circular No. 45/2024 dated 25.10.2024 as One Exam. The SSAs who are eligible as per Circular No. 45/2024 and have already submitted their applications, need not to re-submit their applications.

- 10. Some key points regarding LDCE: -
  - A. <u>Declaration of results</u> A common result will be declared for all the candidates. Further, year-wise merit lists for the separate crucial dates of eligibility (01.07.2022, 01.01.2023, 01.01.2024 and 01.01.2025) i.e. four separate merit lists will be declared.
  - B. Calculation of vacancies The vacancies for the LDCE (with crucial date 01.07.2022) notified vide Circular No. 45/2024 dated 25.10.2024 has now been revised and is 175 {(UR-136, SC-26, ST-13) including PwBD-7(VH-2, HH-2, OH-2, others-1)}. The aforesaid vacancies will be filled with successful Candidates who were eligible till July, 2022. The remaining vacancies will then be carried forward for filling up with successful candidates who were eligible in 01.01.2023 and so on.
  - C. <u>Seniority List</u> The successful candidates will be placed in the seniority list as per the marks obtained by them in their respective year-wise merit list. The successful candidates who were eligible as on 01.07.2022 will be placed above the successful candidates who were eligible as on 01.01.2023 and so on..
  - D. Further, no separate examination will be conducted for the unsuccessful candidates in the year 2025. All unsuccessful candidates(s) will be eligible for the LDCE-2026 and onwards.
- 11. This notification is being issued as an addendum to the Circular no. 45/2024 dt. 25.10.2024.

Note: - The SSAs (Candidates) should clearly understand that this is a competitive and not a qualifying examination. The number of SSAs to be included in Select List/Merit List on the result of the examination is entirely within the competence of the Authority to decide. No candidate will therefore have any claim for inclusion in the Select List/Merit List on the basis of his/her performance in this Examination as a matter of right.
