The appointment on Ad-hoc basis to the post of Senior Account Officer made is made with the condition in case, if any Account Officer on Deputation joins back in DDA, the junior most empaneled candidates in UR category will be considered deemed reverted to the post of Account Officer. The appointment made on ad-hoc basis will not bestow upon the official a claim for regular appointment and the service rendered on ad-hoc basis in the grade would not count for the purpose of seniority in that grade or eligibility for promotion to the next higher grade.

3. No financial benefits shall be allowed to above named officers, if they had already been granted benefit of financial upgradation under ACP/MACP Scheme in Level-10 (Rs.56,100-1,77,500/-) of pay matrix as per 7<sup>th</sup> CPC [PB-3 Rs.15600-39100/- with Grade Pay Rs.5400/- (6<sup>th</sup> CPC)]. If not granted, their pay will be fixed under the provisions of FR.22(I)(a)(1). They may exercise their option for fixation of pay under the provision of FR.22(I)(a)(1) within 30 days from the

date of issue of this order. However, option for fixation of pay from the date of increment in the lower grade will not be admissible to Senior Account Officer promoted on ad-hoc basis.

4. Consequent upon the above promotions, Competent Authority has decided that newly promoted Senior Account Officer, as above, will be posted in the same zone/office, where they are posted as Account Officer.

5. They are directed to submit their joining report to their concerned officer for further duties with a copy to Dy. Director (P)-I. Their promotion will be effective from the date of their joining on the new post.
