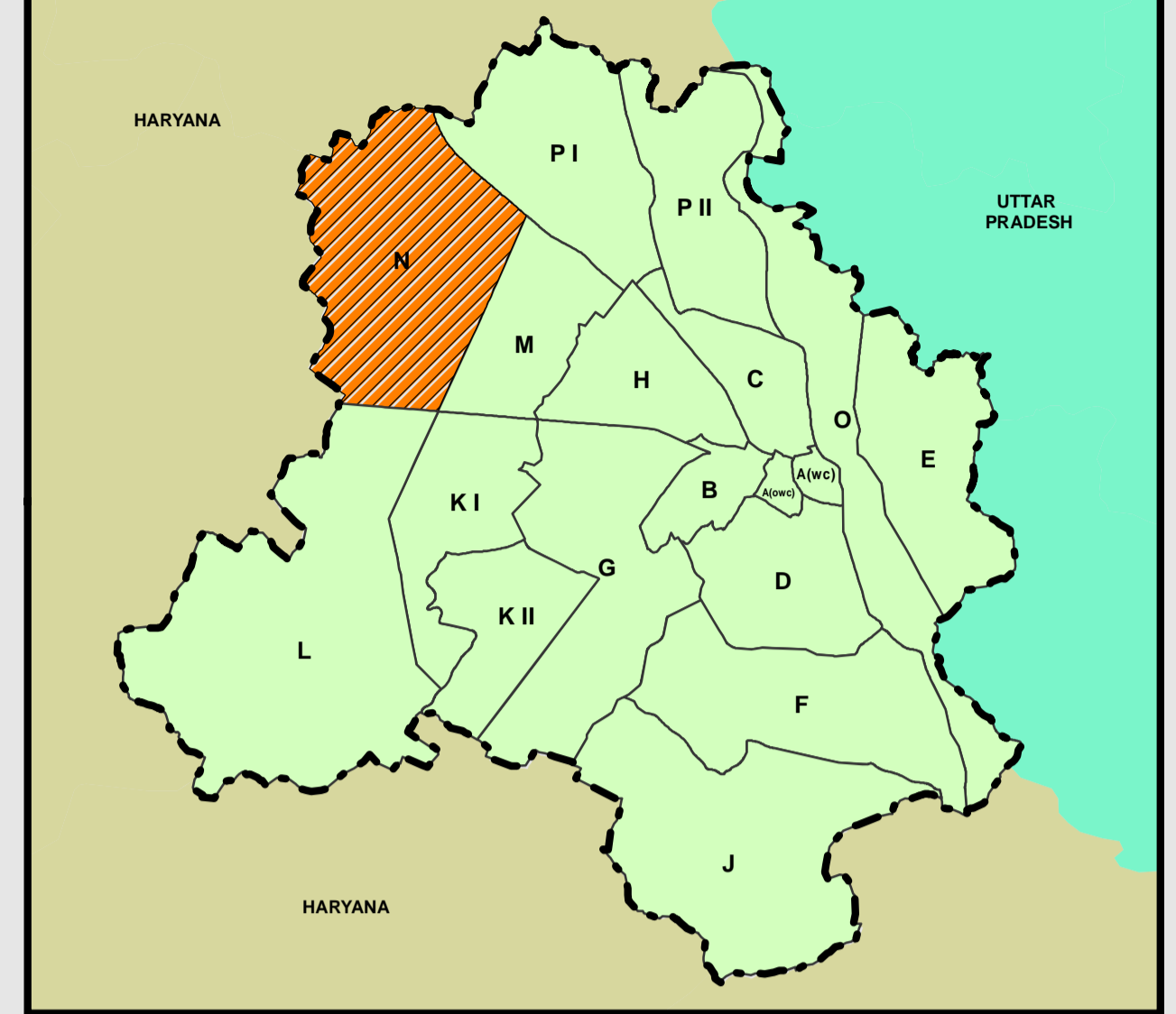
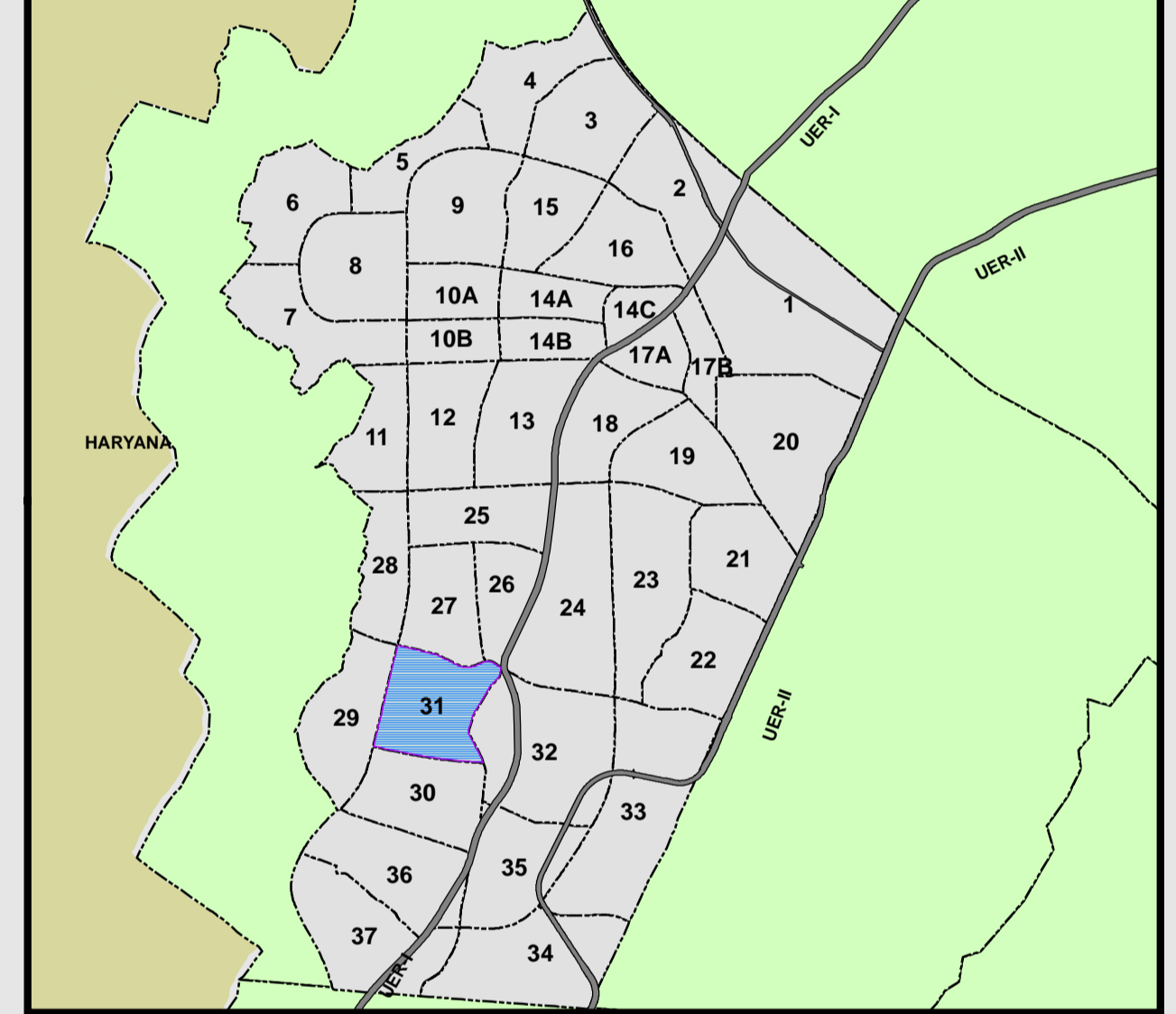


**KEY PLAN - PLANNING ZONAL BOUNDARY- DDA**
