**Sub: Minutes of 44<sup>th</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The 44<sup>th</sup> meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 14.02.2020. List of the officers attended the meeting, is annexed.

During the meeting, the following were deliberated and decided: -

1. Since no observations were received from the members, the minutes of the 43<sup>rd</sup> meeting of STF were confirmed.
2. The status report on removal of encroachment on roads as per the monthly target:

Chairman (STF), again fixed the monthly target for removal of encroachment on road for the month of February. North DMC and SDMC were given target of 100 km each, EDMC 75 km, PWD 50 km and NDMC 25 km for removal of encroachment on the road under their jurisdiction. PWD was again directed to take action on the target fixed by STF and removal of encroachments from major traffic corridors.

3. **Regular Monitored Case:** Removal of encroachment on govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space. EDMC has started the work to provide access to the public to these tot lots. As informed by EDMC, on 15.01.2020, the brick work has been completed in 30 Tot-lots on which iron grills shall be fixed. ATR on the issue are awaited from other ULBs.

**7. ATR on the orders of Hon'ble High Court:** 550 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. It was observed that pendency is highest in DDA(62.5%) followed by North DMC(26.5%) and SDMC (25%). ATR on 416 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Nodal/Grid officers were directed to review the court matters seriously and take action based on the content of writ petition/court direction.

**8. ATR on Complaints forwarded by the Monitoring Committee:** 1365 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 1011 complaints have been uploaded on the web portal and the pendency is 25.93%. Chairman, STF pointed out that the

pendency in disposal of Monitoring Committee complaints is highest in North DMC followed by DDA, SDMC and PWD. This requires review by HODs to reduce the pendency. All concerned agencies to take action on pending cases expeditiously.

**9. ATR on the Complaints more than 6 months old:** At present 1592 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.

**10. ATR on the Complaints regarding On-going unauthorized construction:** The action on ongoing unauthorized construction has not been taken seriously by the local bodies where the pendency is 36.04%. DDA with 48.28% pendency followed by SDMC has 35.33% pendency and North DMC with 39.86% pendency. Again, and again it has been reiterated in the meeting that zero tolerance to be adopted in these cases which has not been maintained by ULBs. ATR with property detail and photograph to be submitted and uploaded.

**11. ATR on the Complaints against Erring Officials/Officers:** Till 31<sup>st</sup> January 2020, 631 complaints against Erring Officials/Officers have been forwarded to STF out of which ATR on the u/c have been uploaded on 494 complaints. Nodal/Grid officers were directed to review the matters seriously and take action.

Status on the 6579 complaints in which detail ATR is not available to be uploaded by ULBs & Govt. Agencies. SDMC has to upload ATR on 5409 old cases, 634 for North DMC, 517 for DDA and remaining pertains to other ULBs/Govt. Agencies. The situation has not been improved in-spite of repeated directions from Chairman STF, the ULBs have not taken any action. The ULBs pointed out that ATR have been uploaded on mobile apps but not opening on the portal .Ther is a lot of discrepancy in the data base related to mobile apps. It was desired that a meeting be held under chairman STF in which Director(Systems) and concerned officers from ULBs will be present to discuss the issue.

14. Representation from Sh. J.S.Goel regarding illegal and improper sanction of Building Plan by SDMC in Sarvodaya Enclave (sns 20200129449) has been received in STF and has been forwarded to SDMC on 31.1.20. The reply on the representation has already been sent to Sh. JS Goel with copy to MoUHA by SDMC in response to MouHA letter no 11013/1/2019-DD-I dated 22.10.19 from UnderSecy, MoUHA on 7.2.20

15. Representation from Sh. Girish Kumar requesting necessary directions to the joint team comprising officials from DDA, SDMC to de-seal the property built over the land bearing Khasra No 309/2 village PulPrahladpur.

- i. Based on the report submitted by the three member committee, the land is private and not Govt.land. The construction on the said Khasra no 309/2 dates back to 2010 and as per the report, the same is protected under Special Protection Act, 2011
- ii. During the discussion, officers of DDA informed that the whole area is denotified. SDMC officers pointed out that the said land is still under the

*denu*



possession of DDA and the land has not been transferred to SDMC. DDA was asked to verify the exact status.

- iii. Hon'ble High Court in the matter Krishna Gopal Gupta vs SDMC and others vide order dated 11.4.2019 in WP(C) 6182/2014 has ordered that "the parties are at liberty to take all pleas as available to them before the Special Task Force which shall be considered and decided by the STF as expeditiously as possible".
- iv. Despite several meetings of STF, considerable time has passed since the orders of the Hon'ble Court. Till date only one Sh. Girish Kumar, Respondent No.5 of the said petition has approached the STF and the other party has neither approached STF nor given any further representation.

In view of the afore-mentioned facts as presented during the meeting, it was decided that a joint action for de-sealing of the property to be taken by DDA and SDMC and prior to this, comments of the legal deptt. may also be sought whether de-sealing can be ordered by STF or direction have to be sought from Hon'ble Court.

16. PWD and ULBs submitted to Chairman, STF that the many of the demolition programmes scheduled by the agencies are postponed due to non-availability of police force. Even the manpower as well as logistics are present at site on the schedule date the programme gets cancelled due to non-provision of police force. These results not only waste of money but also waste of time. Chairman STF directed the ULBs and PWD to send the details of demolition programmes postponed due to non-availability of police force to Co-ordinator STF so that Sp. Commissioner of Police(Law and Order) North/South will be appraised of the situation and issue direction to the concerned SHO of police station to provide police force in future. ULBs and Agencies may prepare a list of future demolition programmes mentioning the concerned Police Station, so that the list can be discussed in the meeting which is also attended by Jt. Commissioner of Police(T) to get it co-ordinated effectively.

17. Any other matter with permission of the Chair

- i. Executive Engineer, ND-1 raised the issue of removal of encroachment in front of North DMC Hospital in Jhandewalan. It was informed in the meeting that joint visit of DDA and North DMC has been done. Chairman, STF directed that joint action may be carried out by DDA and SDMC next week. As informed by EE, ND-1, the date is fixed for 27.2.20. Letter for police force shall be sent by DDA.
- ii. Asstt. Supt. Archeologist, ASI, Govt. Of India vide letter No 6/189/189/2005-M-2705 dated 13.2.20 has requested VC DDA to consider the removal of un-authorized construction within prohibited area of Sheesh Mahal, Centrally Protected Monument, at Shalimar Bagh, Village Haiderpur handed over to ASI by DDA on 23.4.2010 (in two pockets), in order to develop the area around the monument as part of conservation project. Chairman STF directed a joint action be taken up by DDA and North DMC to remove the encroachment. DDA to fix the programme after confirming the litigation status of the encroached pocket

The next meeting is scheduled to be held on **27.02.2020** at **04:00PM** for which no separate meeting notice will be issued. All the members of the STF are


