1. Action Taken Report of the concerned local bodies with respect to the following:

g) Complaints received in the office of Member Secretary, STF till 21.06.2018 have been forwarded to the members of the STF/concerned deptts.

h) Action taken in respect of all the above complaints which were forwarded to the concerned local bodies in the prescribed format duly signed by the Grid officer:

- i) North DMC : **095** out of 111
- ii) South DMC : **015** out of 165
- iii) East DMC : **013** out of 049

- Many ATR are being received without any signature/authentication of the concerned officer.

i) No information has been received till date from NDMC, DDA, PWD, Revenue Deptt., GNCTD.

j) ATR submitted by the above agencies needs to be regularly updated till final action on the matter is taken and file is closed.

2. An interactive web portal with smart phone app. was prepared by the System Deptt., DDA and the link was forwarded to all the grid officers of the concerned local bodies.

i. System Deptt., DDA vide note dated 15.06.2018 submitted the following for consideration of the STF:

- ii. Grid officers from the concerned deptts. stated that their names have been considered without their consent and they are not looking after the activities of encroachment etc.
- iii. They further stated that instead of their names, the names of concerned officers looking after the encroachment etc. should be included from their respective departments.
- iv. The names of officers from SDM office, PDW office, Police and other agencies should also be included in the list.
- v. It was desired that all of them wish to meet the members of the Special Task Force in person to explain their practical problem.

Accordingly, the presentation shall be made by the System Department, DDA so that the app. & website can be launched.

3. Consolidated monthly ATR in the general matters of removal of encroachment/unauthorised construction etc. to be submitted in every STF meeting by the respective concerned local bodies/Govt. Deptts. :

- Till date, consolidated ATR has been received only from South DMC and North DMC.

4. ATR regarding following issues is to be submitted at the earliest:

- a) Encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area. [concerned deptt.: South DMC]
- b) Removal of encroachment from public verandas, Govt./DDA land in Khan Market, Sanjay Market (Mangolpur Kalan) and Masoodpur (Harijan Basti). [concerned deptt.: South DMC, North DMC & DDA]
- c) Encroachment on NDMC lane at Prithvi Raj Road. [concerned deptt.: NDMC]

5. Nodal officers appointed by each local body/department who shall be in constant touch with the Member Secretary of the STF for compilation of ATRs and various others activities.

- a) List of Nodal officers received from North DMC, South DMC, East DMC, NDMC, DJB, Police Deptt. and Fire Deptt. is enclosed for confirmation.
- b) No information has been received from PWD and Revenue Deptt., GNCTD till date.

6. The list of officers at territorial grid/Unit to be identified upto to field level with delineated area of jurisdiction. All officers in the grid will be responsible for all future irregulars and unauthorised construction/violations as per MPD-2021/DMC Act and UBBL-2016:

- a) List of officers at Grid level/Field level received from North DMC, South DMC, East DMC, DJB and Fire Department is enclosed for confirmation.
- b) No information has been received from PWD and Revenue Deptt., GNCTD till date.
- c) Information regarding areas concerned under each territorial grids/unit/ward is still not provided.

- 7. Action Taken Report by the concerned agencies regarding the stopping of construction activity in the unauthorised colony as per orders of Hon'ble Supreme Court dated 24.04.2018.**
 - No information has been received till date from the concerned local bodies/govt. deptts.
- 8. Several incidence have been reported by local bodies wherein the action could not be taken due to following reasons:**
 - a) Lack of sufficient Police force.
 - b) Attack by the local residents on the officers on the site. Engg. deptt., DDA regarding manhandling due to lack of Police personnel.
- 9. Non-furnishing of status report by local bodies/govt. deptts. in case of permanent de-sealing cases as reported by Monitoring Committee vide letter dated 22.06.2018.**
- 10. All local bodies to provide the data/information/ATR in consolidated form to be mentioned before Hon'ble Supreme Court as and when required.**
