However, no information has been received from SDMC, EDMC, NDMC, Revenue Deptts(GNCTD), PWD and DDA.

**2. Action Plan** has not been received from PWD, Revenue Deptt./GNCTD (SE, NE, E Shadara, New Delhi, N, W, Central and NW), North DMC (Karol Bagh Zone), South DMC (West Zone), NDMC and East DMC (Shadara South).

**3. List of Grid/Field officers** has not been received from PWD, GNCTD till date.

**4. Action Taken Report** on the application provided by the concerned agencies are not as per prescribed format.

- a) ATRs provided by the concerned agencies does not contain any specific dispatch number of STF number, hence data cannot be compiled.
- b) ATR received from the concerned agencies appears to be incomplete as it does not mention any status/type of action taken.
- c) Three complaints (1 No. from North-DMC-written complaint; 2 Nos. South-DMC-Telephonic) has been received from the applicants/complainants that no action has been taken on their respective complaints. However, as per the ATR submitted by the concerned local bodies the encroachment has been removed.
  - i) Case of Sh. Sanjay Gupta regarding encroachment on road and footpath opp. to H. No. C-1 & C-1/2, Rana Pratap Bagh by Delhi Police constructed illegal Beat Box. (Concerned ULB: North DMC).
  - ii) Case of Col. Shivraj regarding encroachment on Baba Gangnath Marg, Nelson Mandela Road and at Lawn No.7, Munirka Vihar. (Concerned ULB: South DMC).
  - iii) Case of Sh. Sunil Sharma regarding encroachment on main road from Ber Sarai crossing to A-Block Market, Munirka & encroachment on the common and green spaces and unauthorised residents of DDA Flats , Munirka, Delhi (Concerned ULB: South DMC).
- d) Video-graph/photographs to be submitted along with ATRs of the public grievances as a documentary proof.
- e) No follow-up/updates of ATRs which pertains to any other govt. agencies/ULBs for instance:
  - i) In the matter of Sh. Purshotam Behl regarding encroachment on NH-08 near Village Rangpuri wherein EE(B)Nazafgarh Zone/SMDC has referred NHA1 for taking necessary action.
  - ii) In case of Sh. Rajesh Kumar regarding encroachment and unauthorised construction at Wazirpur JJ Colony Patherwala Bagh, D-24 Extn., Grid officer/North DMC has mention DUSIB for necessary action.

**5. Hon'ble Supreme Court** vide Order dated 18.07.2018 directed that:

- a) **Show Cause notice be issued not giving more than 48 hours time (excluding holidays) to the alleged defaulter to respond to the show cause notice.**
- b) **STF to explore the possibility of digital mapping** in Delhi. The checklist of doing such survey is enclosed for discussion.

**6. Consolidated monthly ATR in the general matters of removal of encroachment/unauthorised construction etc. to be submitted in every STF meeting by the respective concerned local bodies/Govt. Deptts.**

**7. Specific issues discussed in STF meeting from time to time:**

- a) Encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area. [concerned deptt.: South DMC]
- b) Removal of encroachment from public verandas, Govt./DDA land in Khan Market, Sanjay Market (Mangolpur Kalan) and Masoodpur (HarijanBasti). [concerned deptt.: South DMC, North DMC & DDA]

**8. Problem being faced by concerned agencies in implementation of Mobile APP.**

- a) There is no mode to transfer / forward the complaints received by the Nodal officers to the concerned zones / grid officers.
- b) Format for the submission of ATR of the same i.e., either online or through any other mode.
