- 2. ATRs are not being provided by the concerned govt. agencies on a weekly basis, hence data cannot be compiled in a time bound manner. All the agencies are again requested to submit consolidated report in a prescribed format enclosed herewith on weekly basis duly signed by the concerned officer.
- 3. Complaints received in the office of Chairman, STF and Member Secretary, STF till 10.08.2018 have been forwarded to the members of the STF/Nodal officers of the concerned deptts.
- 4. ATR to be submitted by all the concerned agencies w.r.t. the minutes of earlier meetings
- 5. ATR related to the application/grievances received from the Monitoring Committee (MC) has not been received from the concerned ULB, till date.
- 6. Follow up/updates of ATR which pertains to any other govt. agency/ULBs has not been received.

7. Draft guidelines for blacklisting of Builders/Contractor/Architects were circulated by hand and e-mail to all the ULBs, govt. agencies and Amicus curiae. However, till date, the same has been received from South DMC and EDMC only.
8. A meeting was held with the chairmanship of Pr. Comm.(Coordinator), DDA with the representatives of GSDL for explaining the possibility of digital mapping of Delhi on 14.08.2018. GSDL along with system deptt. DDA has been requested to give a presentation during the STF meeting for having views of all the members of STF in the matter.
9. Other Issues:
  - Various complaints has been received from the complainants regarding delay in disposal of their grievance forwarded to the STF.
  - In the matter of Station House Officer, PS Timarpur (211-STF), regarding the re-encroachment created by the owners from Mother Diary to gali no. 4, main market Wazirabad village, wherein North DMC has referred I & FC department for taking necessary actions.
