- 2. Complaints received in the office of Chairman, STF and Member Secretary, STF till 24.08.2018 have been forwarded to the members of the Nodal officers of the concerned deptts.
- 3. List of applications / grievances received from the Monitoring Committee (MC) was forwarded to the Nodal Officers by e-mail on 27.08.2018. However, no ATR has been received on the same, till date.
- 4. Despite of regular reminders, ATRs (specifying the type of action taken) are not being provided by the concerned govt. agencies / local bodies in consolidated format within time.
  - Due to this appropriate reply / data could not be furnished before the Hon'ble Supreme Court.
  - All the agencies are again requested to submit consolidated report in a prescribed format every week on Friday duly signed by the concerned officer.
- 5. A presentation on action taken on public grievances (category-wise), number of property sealed/de-sealed, area re-claimed in anti-encroachment drive, action plan etc. is to be made by the concerned local bodies / govt. agencies in every STF meeting separately.
- 6. Complaints not addressed / registered to the STF shall have to be treated separately by respective departments and may not be linked up with the STF.

- 7. A request has been made to the System Deptt, DDA vide e-mail dated 20.08.2018 regarding transferring of grievances received from Mobile app. on the e-mail ID of the Nodal officers of the Delhi Traffic Police and Delhi Jal Board.
- 8. Nodal officer has been appointed by DUSIB, GNCTD. However, list of grid officer is yet to be provided to the System Deptt., DDA by the DUSIB.
- 9. Commissioner (LD), DDA vide letter dated 08.08.2018 has sought action from the Delhi Traffic Police regarding encroachment of land at Geeta Colony which was allotted to Deptt. of Health and Services, GNCTD.
- 10. Issues for consideration as mentioned in Report No. 127 of Monitoring Committee (SC) in the matter of M C Mehta Vs Union of India:
  - Illegal constructions in the areas of Burari (North-DMC), Vishwas Nagar (East-DMC), Kishangarh, South Zone (South-DMC & DDA), encroachment of DDA land at Karkardoma Metro Station (DDA & East-DMC), Bhatti Mines areas of South-DMC.
  - Adequate Police protection to enforcement agencies.
  - Digital mapping of Delhi.
  - Update on the Mobile App. 311 DDA- for filling a detailed status report of action taken (category wise).

11. Other Issues:

• In the matter of Shri K.C. Bhargawa wherein a grievance has been furnished regarding encroachment on Ridge land by Sanatan Dharm Sabha, Laxmi Narayan Temple Trust, Mandir Marg – Requirement of representative of Forest Deptt., as co-opted member of STF.
