- 2. Updated master list (in excel format) including grievances sent through mail upto 13.09.2018 have been sent to all the concerned agencies.
- 3. One consolidated ATR which needs to be submitted by each concerned local body (instead of zone wise as per prevailing practice).
- 4. Consolidated ATR on Anti-Encroachment Drive and Number of properties Sealed De-Sealed to be submitted by all the concerned agencies in a prescribed format (copy enclosed) on weekly basis duly signed by the concerned officer as submitted in the court. The location of encroachment removed also to be submitted with details.
- 5. Hon'ble Supreme Court vide Order dated 07.09.2018 directed the following:
 - a. Any complaint made by the Monitoring Committee brought to the notice of this court will be taken up with all due seriousness.
 - b. Hon'ble court has taken a serious view on the increasing encroachment of public land and roads in Delhi and has directed all the statutory authorities to take up the matter of clearance of encroachment on road with great urgency.
 - c. Once the Special Task Force clears the encroachments, the statutory bodies will ensure that there is no further encroachment on the cleared portions.
 - d. Forest authority to make all efforts to retrieve the encroached land in Asola, Bhatti Mines and other areas under their jurisdiction.
 - e. Delhi Jal Board to take steps to revive the water bodies in Delhi which have dried up and encroached upon or acquired for infrastructural development.

6. Other Issues:

- a. Monitoring committee vide letter dated 30.08.2018 has sought compliance report along with the photographs in the matter of sealing of Property No. D-16, Prashant Vihar, New Delhi 110085 by North DMC
- b. As per report received from UTTIPEC and LM Deptt. DDA, removal of encroachment for development of existing Ring Railway network in Delhi may be seen by STF.
- 7. In addition to above, all the concerned ULBs have to bring the following details in the meeting for apprising the Hon'ble Court in the next hearing:
 - a. Shop cum residential complex, list of LSC and CSC along with the road width abutting the said markets.
 - b. List of Parking Lots (existing and proposed) in or near LSC and Shop-curesidential plots and their status with respect to action taken after allotment/identification.
 - c. List of pedestrian streets (declared, under process and proposed).
 - d. Action taken w.r.t. implementation of notification dated 21.06.2018.
 - i. Actions related to regularization/sanctioning of revised plans.
 - ii. Actions taken for infrastructure upgradation in such areas and other areas brought under redevelopment.
 - iii. Number of streets pedestrianized under the said notification.
 - iv. Provisions of Solid Waste Management/plants setup so far.
