- 4. Pending action taken report:
  - (a) For issues referred by Monitoring Committee and discussed in the earlier meeting of the STF:
    - i. No report has been submitted by South DMC in the matter of removal/clearance of encroachment and retrieval of govt. land in village Khilokri /Taimur Nagar.
    - ii. North DMC has not provided report in the matter of removal of dangerous unauthorized structure at Gayetri Colony, adjacent to Katpulti transit camp, Anand Parvat.
    - iii. Status report not received in respect of sealing and retrieval of govt. land from unauthorized construction viz. Islam Colony, Nat Colony, Rana Colony etc. near Kishangarh, Mehrauli as directed by the Monitoring Committee (Pertains to DDA & SDMC).
  - (b) For references received from Monitoring committee and forwarded to the concerned agencies:
    - i. Letter vide dated 16.10.2018 wherein status report has been sought w.r.t. sealing of the motels. The matter was earlier placed before the STF in its  $12^{th}$  meeting. (Pertains to North DMC & SDMC). Refer annexure-1
    - ii. Note vide dated 18.10.2018 w.r.t. removal / clearance of encroachment and retrieval of govt. land in Taimur Nagar, Zakhir Nagar, Batla House and along the bank of Yamuna river (refer annexure-2).

The action taken report is required in the above-mentioned cases.

- 5. 30 Nos. of complaints seeking disciplinary actions against erring officers/officials of ULB/govt. agencies have been received but action is pending at the level of ULB /govt. agencies. These complaints have been forwarded to respective Addl. Commr. But no communication has been received in compliance of point 2(ii) of office memorandum dated 23.05.2018 issued by MoHUA, GOI, regarding formation of three-member committee for immediate cognizance in such matter.
- 6. Status Report is awaited from the local bodies w.r.t. Hon'ble Court vide order dated 07.09.2018, regarding removal of encroachment for rejuvenation of the water bodies.
- 7. As per various telephonic conversation with complainants, it is has been observed that some grievances are being submitted directly to the user ID of Dy. Dir.(Plg.)/MP, DDA by the complainant itself. However, as per the 12th meeting of the STF, it was deliberated that only for identification of Nodal officer, such complaints shall be transferred by the Nodal officers only. Accordingly, System Deptt., DDA may take appropriate measure to resolve the issue.
- 8. Various grievances have been received from complainants that some of the nodal officers of the STF are not incorporated (eg. DUSIB, Revenue Deptt. etc.) in the mobile app. (i.e., DDA311). Therefore, System Deptt., DDA is to ensure that the

- details of all the nodal officers, members and co-opted members of the STF be incorporated and duly updated.
- 9. In the matter of Jagpal Singh Vs GNCTD and ANR [WP(C) No. 11410/2015] wherein Hon'ble High Court of Delhi vide its order dated 23.05.2017 has directed DDA to remove illegal encroachment over the pond situated in Badarpur Village, South-East Delhi (refer annexure-3).

# 10. Pending Action taken report:

- a) As placed before the STF in its 13th meeting:
  - i. In the matter of Sh. Subodh Kumar Wadhwa regarding misuse of premise No. C-1, C-1/1 and C-1/2, Ring Road, Nariana, New Delhi, wherein the complainant has accused officers/officials of North DMC for making false declaration in favour of de-sealing of the said premises.
  - ii. In the matter of Sh. P.C.Pande regarding damaging the balcony of the complainant for protecting the encroachment by distorting the facts. Further, the complainant has requested investigation/enquiry on his case in terms of para 2(i) and 2(ii) of O.M. dated 23.05.2018 issued by MoHUA, GOI. (North-DMC)
  - iii. In the matter of Dr. Manjula Krippendorf, regarding demolition of structurally unsafe illegal building (as per health assessment done by MAC Consulting Engineers) at B-56, Defence Colony, New Delhi. (South-DMC)
  - iv. Complaint has been received from Encroachment control wherein it has sought disciplinary action against responsible officers/officials as mentioned in the O.M. dated 23.05.2018 due to inaction in the matter of illegal extension made by Shop No. 3 Cascade complex, Netaji Subhash Place where demolition action has been delayed for more than 3 years. (North-DMC).


In continuation of the previous orders dated 28th September 2018 and subsequent reminder dated 04th October 2018, the Monitoring Committee has decided to take immediate sealing action in respect of the Motels where the shape and size of the Motels have not been maintained as per Sanctioned Building Plan / Occupancy (Completion) Certificate. The seal shall be affixed in such Motels at entry points.

The Monitoring Committee has already issued instructions vide previous letter for issuance of Show Cause Notices before the sealing action so it is presumed that all the Motels have already been served upon Show Cause Notices by the D.C. concerned.

In so far as temporary de-sealing is concerned for holding already booked functions, the concerned owner/occupier may approach the Monitoring Committee for temporary de-sealing specifically for the functions.

Monitoring Committee submits that schemes for public facilities can not be implemented until and unless the so called encroachments and unauthorised constructions over large part of the DDA land are removed.

In view of the above, Special Task Force (STF) may kindly look into the matter and take immediate steps for removal/clearance of encroachments and retrieve the prestigious DDA land in <u>Taimur Nagar</u>, <u>Zakhir Nagar</u>, <u>Batla House & along the bank of Yamuna River</u>, as per the details enclosed, at the earliest.

But no measures have been taken by DDA in order to incorporate those orders.

4. Some of the corrupt officials of DDA like the Director of Gardening, Sh. Shripal, Dy Dy. Sh. Badal Kumar, SE Miglani and other unidentified officials and employees are showing nothing but Dark Silence, negligence and apathy regarding this illegal encroachment. - 1. This writ petition is concerned with preservation of a "Jauhad" a water body in Badarpur. The photographs placed on record show squatter deplorable conditions and a large body of stagnant water. In the response, which has been filed, the respondents have completely abdicated any responsibility qua this land.
- 2. While Government of NCT of Delhi squarely absolves itself of any responsibility by stating that the land has been transferred to the Delhi Development Authority, DDA submits that this land is not a water body and is a JJ Cluster. This submission is made W.P.(C) 11410/2015

  Page 1 of 3

despite the revenue record clearly reflecting that the land in question is a "Jauhad".

- 3. ' Ld. counsel for the petitioner has placed before us a pronouncement of the Supreme Court dated 28<sup>th</sup> January, 2011 in Civil Appeal No.1132/2011 Jagpal Singh & Ors. v. State of Punjab & Ors., wherein in para 16, the court had stated thus:
  - "16. The present is a case of land recorded as a village pond. This Court in Hinch Lal Tiwari vs. Kamala Devi, AIR 2001 Sc 3215 (followed by the Madras High Court in L. Krishnan vs. State of Tamil Nadu, 2005 (4) CTC 1 Madras) held that land recorded as a pond must not be allowed to be allotted to anybody for construction of a house or any allied purpose. The Court ordered the respondents to vacate the land they had illegally occupied, after taking away the material of the house. We pass a similar order in this case."
- 4. There can be no manner of doubt that a water body has to be preserved, maintained and utilized as a water body and nothing at all. No encroachment thereon can be permitted.
- 5. In this background, the DDA shall place on affidavit the position with regard to the water body; setting out its extent, contours and the steps which it is going to take to restore the same. In case, relocation of any person is required, the same would be done after interaction with the DUSIB and steps taken with regard thereto.

- 6. Needless to say this matter brooks no delay and has to be implemented on war footing especially, keeping the advent of monsoon in mind.
- 7. The DDA shall file an affidavit setting out the information and the steps which they propose to take within four weeks from today.
