2. Action Taken Reports are not being received on fortnightly basis from the concerned local bodies/govt. agencies in a consolidated format as directed from time to time in various STF meetings.
3. Month wise pendency list/status/reasons for delay of all the complaints to be submitted. The list of complaints pending for 3 months or more to be put separately positively in this meeting.
4. No Action Taken Report(ATR) have been received against erring officers/officials of ULB/govt. agencies.
5. Status report is awaited from the local bodies w.r.t. Hon'ble Court vide order dated 07.09.2018, regarding removal of encroachment for rejuvenation of water bodies.
6. Action Taken Reports(ATRs) on the case specific issues discussed in the earlier meetings of STF in not submitted.
7. GNCTD has sought grant of NOC/Fire Clearance certificate by Fire Department for the operationalisation of Community hall at Kishangarh, Sector-A, Vasant Kunj by providing:
 - a) 9m ROW on footpath abutting main entry gate of Kishangarh Community hall
 - b) Arrangement for removal of pandel tent shades erected by Radha Swami Satsang at adjacent plot of the Community Hall
8. Applicant has requested for preparation of manual of instructions for unauthorized construction by DDA on similar lines as done by MCD and NDMC.
9. As the Agenda for the STF meeting is being circulated two days in advance of the STF meeting (as per 14th minutes of STF meeting), hence the updated consolidated ATRs in the prescribed format is to be submitted by all the ULBs/concerned govt. agencies at least 3-4 days prior to the STF meeting.
10. Draft format prepared for the web-portal of the STF as an integrated platform for consolidation of report by the local bodies / govt. were circulated by hand and e-mail to all the ULBs, govt. agencies for objection and suggestions. However, till date, the same has been received from DUSIB only, therefore the format will be finalized.
- 11. Court Cases: These are urgent matters, therefore report to be submitted in the STF meeting on 16th Nov. 2018.**
 - a) Status report is awaited from SDMC w.r.t Hon'ble court vide order dated 01.11.2018, regarding unauthorized construction at Khasra No. 379, Gujar Mohalla, Village Chandan Hulla, New Delhi-110074 at the earliest.
 - b) In the matter of Help Indian Against Corruption Through: Its president Sh. Manoj Kumar Sharma vs North Delhi Municipal Corporation and Ors. [W.P.(C) No. 5851/2018] wherein Hon'ble High Court vide its order dated 10.10.2018 has directed SDMC to file status report related to illegal/unauthorized construction in Anand Parvat Industrial area, Delhi-110005 in 6 plot.
12. In the case specific issues mentioned on 02.11.2018, Action Taken is required on 16.11.18.

Pandal/tent shade erected by Radha Swami at right of way needs to be removed on urgent basis. Kindly refer to our communication No. F4(1)AE(P)/SWD-2/DDA/17-18/1611 dt. 9.05.2018(Annexure-'I') and followed by reminder No.1905 dt. 25.07.2018 (Annexure-'II') seeking your most urgent attention/intervention for making 9.00 meter right of way to community hall of Kishangarh, Sector-A, Vasant Kunj for grant of NOC/fire clearance certificate by Fire Department and its subsequent functioning.

We feel regret to inform that the 9.00m right of way by your department has not yet been provided delaying avoidable delay in functioning of community centre.

It is also observed that plot adjacent to such community hall belongs to Radha Swami Satsang and a permanent pandal/tent shade is visible there encroaching the right of way.

You will please appreciate that Hon'ble High court of Delhi has very strongly worded has indicated that no hindrance/obstructions can be tolerated and should be immediately removed for ensuring smooth and uninterrupted movement of people and fire tenders in any eventuality.

You are requested to bestow your most preferred attention to:

- (i) Provide opening/cut of 9.00 meter on footpath abutting main entry gate of Kishangarh Community Hall.

This matter pertains to unauthorized construction at Khasra No. 379, Gujar Mohalla, Village Chandan Hulla, New Delhi-110074. In the matter of illegal/unauthorized construction, this Court has passed a detailed order dated 20.09.2018 in W.P.(C) No.1807/2018 titled as Devender v. Government of NCT of Delhi & Ors. and connected cases (batch of 16

cases) wherein we have taken note of the fact that Hon'ble Supreme Court is seized of the issue pertaining to illegal constructions both ongoing and constructions already concluded and passed various orders including orders dated 24.04.2018 and 18.07.2018 passed in *Writ Petition(s) (Civil) No(s). 4677/1985 M.C. Mehta v. Union of India & Ors.*

We are informed that based on various directions issued by the Hon'ble Supreme Court, the Delhi Development Authority vide Office Memorandum No. O-33011/1/2006-DDI dated April 25, 2018 has constituted a Special Task Force consisting of about 15 Members, the objective of the Task Force and the Rules and procedure for functioning of the Task Force has been brought to our notice.

That apart, by another Office Memorandum No. O-33011/1/2006-DDI issued by the DDA on May 23, 2018, an action plan for monitoring all ongoing construction activities in Delhi, fixing of responsibilities in case of violation of Master Plan, unified Building Byelaws and issues with regard to illegal constructions have been dealt with and even a plan for receipt of complaint with regard to illegal and unauthorized constructions already made and steps to be taken for their removal have been indicated.

Keeping in view the aforesaid, the purpose of the present writ petition filed before us in public interest stands fulfilled.

Accordingly, this writ petition is disposed of with liberty to the petitioner to file a complaint before the appropriate Committee as indicated hereinabove.

The South Delhi Municipal Corporation of Delhi is directed to file latest status report before the Special Task Force within 15 days from today. Till the matter is taken up by the Special Task Force, all construction

activities in the area shall remain stayed, until and unless granted permission by the Special Task Force.

Parties are directed to appear before the Special Task Force with the certified copy of this order on 12th November, 2018. It is further clarified that in case there is any breach of the interim order passed by this Court, the petitioner shall be at liberty to invoke the jurisdiction of this Court in that respect.

The date already fixed in this matter i.e 14th November, 2018 stands cancelled.

I want to draw your kind attention towards the land and builder mafia in Anand Parvat Industrial area. This is an industrial area and only industrial activity is allowed. This land belongs to Ramjas Foundation. Land and builder mafia has active in this area for last many years. There has developed a nexus of land mafia, Police, officers of MCD, revenue staff and local councilors. First land mafia occupied the vacant land with the help of Police and revenue staff and after that they raised illegal constructions with the help of MCD staff and local councilors. As per information of complainant, MCD officers are charging approx. three lacs rupees per lenter for hundred sq. yard fresh construction. And office bearers/staff has been charging approx. twenty lacs rupees for hundred sq. yard lease agreement. And they are not objecting the illegal construction on the plots.

I noticed some illegal constructions in this area. List of illegal constructions are as under follows:-

No builder/occupier of above said properties sanctioned their site plan from concerned authority. And they are not the actual owner of these properties.

In this context earlier I filed a complaint on 02.01.2018. But no action has been initiated against the land/builder mafia by any of you. After that I filed an application under RTI Act 2005 and sought ATR and allied information in respect of above said complaint. But building department of City S P Zone did not initiate any action against the said illegal constructions.

I filed PIL No. 5851/2013 in Hon'ble Delhi High Court. Hon'ble Chief Justice Sh. Rajendra Menon dispose off the PIL and provide us the liberty to file our complaint in front of STF. Copy of order is enclosed with this representation.

So, therefore you are requested to initiate action against the said illegal constructions and action should be taken against the concerned officials of builder department who provided shelter to these defaulters.

Government of NCT of Delhi & Ors. and connected cases (batch of 16 cases) wherein we have taken note of the fact that Hon'ble Supreme Court is seized of the issue pertaining to illegal constructions both ongoing and constructions already concluded and passed various orders including orders dated 24.04.2018 and 18.07.2018 passed in *Writ Petition(s)*

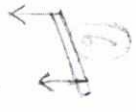
