a) This is with reference to the following court matters which is coming up for hearing on 24.12.2018 (Monday):

b) The matter in all the above 3 cases is related to the unauthorised construction in the following properties:

3. WZ - 1541, Rani Bagh, Shakurbasti, Delhi

c) In the above matters, Sr. Civil Judge, Rohini Distt. Court has recorded in its orders dt. 20.11.2018 / 22.11.2018 that there are huge number of cases pending in the civil court due to inaction / inefficiency on the part of officials of North MCD. Therefore, Vice Chairman, DDA / Chairman, STF and Commissioner, North DMC / Member, STF has been issued notice for information and necessary action, as under the law primarily.

d) On going through the above orders, it is understood that the matter is coming up on 24.12.2018 for further report on demolition / sealing and arguments.

e) The area under reference (i.e. Rani Bagh, Shakurbasti, Delhi) falls under the jurisdiction of North Delhi Municipal Corporation (North DMC) as such any action against the unauthorised construction / demolition and errant officials is to be taken up by the North DMC only.

f) DDA is involved merely because of the Special Task Force which is constituted for enforcement of provisions of MPD-2021 and UBBL for Delhi and monitoring of illegal constructions and encroachments on public land, parking space, road etc. comprehensively and monitoring the actions taken by the local bodies.

**g) In compliance to the orders dt. 20.11.2018 / 22.11.2018 of the Hon'ble Court, all the above listed matters [at a) above] shall be put up in the next meeting of Special Task Force, likely to held on 28.12.2018 (Friday), for consideration and appropriate decision / direction.**

**Sub: - Complaint of unauthorized constructions in the past.**

This has reference to the office Memorandum published in the Hindustan Times dt. 31-05-2018 inviting complaints of unauthorized constructions in the past, we give below the details of unauthorized constructions on DDA land in our colony and on 80' road of our colony.

Aviation Employees Co-operative House Building Society Ltd, Gagan Vihar was allotted 200 bighas 11 biswas of land as per lease deed dt 08-07-79 between the Society & the President of India,

A copy of lease deed is enclosed.

The Society was not given possession of full area of 200 Bighas 11 bigwas on account of encroachments on DDA land as is also stated in the cover page of Lease Deed-

The following encroachments should be demolished from.

1. Plots no 304 to 315 as marked Yellow in the attached layout plan of the society.
2. Encroachment on 80' road in front of houses no 304 to 317.

It may be mentioned that as per Registered Conveyance Deed/ Lease Deed, there is 80' road in the north of houses no. 29 to 35, 274 to 317. The full width of 80' foot road is not available in front of some of these houses due to encroachments whereas full 80' road has been encroached in front of houses no. 304 to 314. Since this has resulted in road block and flow of Trunk Traffic is hampered, these encroachments should be demolished. The flow of trunk traffic from East to West and vice versa is blocked with the result the trunk traffic is passing from West gate of our colony to the North gate of our colony to reach that fast side, this is causing Noise and Air Pollution in the colony apart from damaging internal roads of the colony which are 30' & 45' wide and which are unfit to take the load of Trunk Traffic.

Kindly demolish all above encroachments

**Sub: - Complaint of unauthorized constructions in the past.**

This has reference to the office Memorandum published in the Hindustan Times dt. 31-05-2018 inviting complaints of unauthorized constructions in the past, we give below the details of unauthorized constructions on DDA land in our colony and on 80' road of our colony.

Aviation Employees Co-operative House Building Society Ltd, Gagan Vihar was allotted 200 bighas 11 biswas of land as per lease deed dt 08-07-79 between the Society & the President of India,

A copy of lease deed is enclosed.

The Society was not given possession of full area of 200 Bighas 11 bigwas on account of encroachments on DDA land as is also stated in the cover page of Lease Deed-

The following encroachments should be demolished from.

1. Plots no 304 to 315 as marked Yellow in the attached layout plan of the society.
2. Encroachment on 80' road in front of houses no 304 to 317.

It may be mentioned that as per Registered Conveyance Deed/ Lease Deed, there is 80' road in the north of houses no. 29 to 35, 274 to 317. The full width of 80' foot road is not available in front of some of these houses due to encroachments whereas full 80' road has been encroached in front of houses nom 304 to 314 Since this has resulted in road block and flow of Trunk Traffic is hampered, these encroachments should be demolished. The flow of trunk traffic from East to West and vice versa is blocked with the result the trunk traffic is passing from West gate of our colony to the North gate of our colony to reach that East side, this is causing Noise and Air Pollution in the colony apart from damaging internal roads of the colony which are 30' & 45' wide and which are unfit to take the load of Trunk Traffic.

Kindly demolish all above encroachments
