- 3. Till date 3480 grievances received through hard copy have been uploaded on the Integrated web portal. Twenty One Action Taken Reports (ATR) have been uploaded on the web-portal by NDMC and other ULBs/govt. agencies have not uploaded their ATRs on web portal. In addition to this 1629 complaints have been uploaded directly on the STF web portal which is required to be seen by the Nodal and Grid officer for taking action and uploading the ATR on STF web-portal. Training facility available in the STF office for the nodal and grid officers at 6th Floor Vikas Minar.
- 4. NDMC and Delhi Jal Board(DJB) were directed to appoint one Nodal Officer for their agency and submit their details in the Office of Special Task Force (STF) Cell at 6th

Floor, Vikas Minar, Delhi at the earliest to avoid confusion in forwarding the complaints to the ULBs/govt. agencies. The same is awaited from DJB and NDMC.

- 5. Issues regarding repetitive Inter-departmental and Intra-departmental transfer of grievances to one another thereby leading to delay in action taken on the complaints.
- 6. In the matter of Sh. M. Khemchand regarding Illegal construction and encroachment in 427 and 429 DDA SFS Flats sec 11 Rohini. Sealing order has been passed by the competent authority but sealing action could not be taken due to non-availability of police force on 28.12.2018, 03.01.2019, 04.02.2019 and 18.02.2019. Sealing action will be taken in due course of time. Delhi Police may be requested to provide the police force so that further action be taken by North DMC.
- 7. 5 CPGRAM and 2 PMOPG received in STF Cell filed by Sh. Surajmal related to unauthorized construction at E-72A, Jawahar park, Devli road. It has been requested, keeping in view, the provision of office memorandum dated 23.05.2018 issued by MoHUA to issue show cause notice to grid officer why no action be taken against him under section 13(1)d of prevention of corruption act 1988 and if reply is not satisfactory, FIR should be lodged against him for allowing unauthorized construction.

The above grievances have been forwarded to nodal officer of SDMC on 25.02.2019 for necessary action. SDMC to provide status report and reply to the applicant and copy to PMO for necessary information.
