4. Public Hearing cases discussed in 22nd STF meeting:

- a) In the matter of Sh. Jag Dev Singh regarding illegal and unauthorized construction on the rooftop of flat no. 455, pocket-B, Phase-II, Sector-13, Dwarka, new Delhi-110078, metro View Apartment. The case was also discussed in 16th STF meeting held on 30.11.2018. The case pertains to SDMC. The complainant submitted that demolition has not carried out completely and DJB to remove water tank from mumty.
- b) Sh. Ram Karan, secretary, RWA Anand Vihar Colony Demolition and unauthorized construction on gram sabha land, Khasra no. 87/77, Barwala, status report is awaited from Revenue Deptt. GNCTD.

- c) Sh. Manjeet Singh Malta regarding: Action against illegal and unauthorized construction being raised in 1615, outram line and complaints against officials and MCD and request for investigation, status report is awaited from North DMC.
- d) Sh. Harcharan Singh Sehgal unauthorized construction on 298, 300, 333, 526 Bhai Parmanand colony, 295 Dhakajohar and 532, 533, 629 etc. Mukherjee Nagar and complaint against MCD officials, status report awaited from North DMC.
- e) Sh. Archit Monga, Removal of encroachment and unauthorized construction property no. 99, Gujranwala town. Satus report awaited from North DMC.

5. Specific issues for discussion:

- a) In the matter of Sh. R.N. Kaushik regarding illegal encroachment/constructions at Pt. Lekhram Sharma Marg (Tampura Main Road) in Rampura Municipal ward no. 70N, alleging that the report on removal of encroachment is not correct
- b) Executive Engineer, Flyover Division No. 4, DDA vide letter dated 11.02.2019 to DCP(Traffic) and the Director (Night Shelter) DUSIB has requested to shift the seized vehicles and night shelter respectively from plot no. 4, Nehru Place since this plot has been scheduled for auction.
- c) Dy. Registrat(PIL) vide letter no. 1161-W/PIL/230/DHC/2018 dated 17.01.2019 addressed to V.C., DDA, Chairman, STF to take necessary action on the complaint filed by Mr. Brijpal Upadhyay regarding illegal construction in Sainik Farm, N-Block, W-17, K-5 MCD ward 78-S in spite of ban by Delhi High Court on constuction. The reference has been forwarded to nodal officer, STF, SDMC on 08.02.2019. No action report has been received till date.
- d) The complaint from Sh. Bijoy Kant forwarded by Monitoring Committee to Chaiman, STF regarding Encroachment on government land and huge Illegal and unauthorised construction on flat no. 1140 of sector B-1, Vasant Kunj. The complaint was forwarded to SDMC on 8.8.2018. No action taken report has been received from SDMC.
- e) Complaint by Sh. J.D as Advocate against Uday Singh, MD Namdhari seeds Pvt. Ltd. And others on encroachment and unauthorized occupation of DDA/govt. land measuring 3 acres approx. situated in front of House No. 1 C/1, Namdhari Colony, Ramesh Nagar. The complaint has been forwarded by Monitoring Committee on 05.03.2019 and received in STF on 14.03.2019. the complaint has been forwarded to North DMC and DDA for taking appropriate action on 14.03.2019. The above said agencies to submit the action taken report to STF.
- 6. **Uploading of ATR on STF web portal**: 4032 grievances received through hard copy till 12.03.2019 have been uploaded on the Integrated web portal. Only 152 Action Taken Reports (ATR) have been uploaded on the web-portal by ULBs/govt. agencies. All ULBs/govt. agencies be directed to upload their ATRs on the STF web-portal and complete the assignment by next STF meeeting.

In addition to this 1720 complaints have been uploaded directly on the STF web portal which is required to be seen by the Nodal and Grid officer for taking action and uploading the ATR on STF web-portal. Training facility available in the STF office for the nodal and grid officers at 6th Floor Vikas Minar.

7. **Appointment of single nodal officer**: NDMC was directed to appoint one Nodal Officer in place of three nodal officers for their agency and submit their details in the Office of Special Task Force (STF) Cell at 6th Floor, Vikas Minar, Delhi at the earliest to

avoid confusion in forwarding the complaints to the ULBs/govt. agencies. The same is not received from NDMC till date.

11.Site Visit:

a) A team of STF officers comprising Co-ordinator STF, Asst. Dir.(STF), A.E., North DMC visited Vikaspuri as directed by Chairman, STF. Mr. Brij Kishore, AE and concerned JE were also present during the site visit. A power point presentation has been prepared and will be presented. Observation Prima facie:

It is noticed that the encroachment/unauthorized construction has been carried out in most of the flats in form of the following:

- i. Encroachment on govt. land/roads and projection on govt. land.
- ii. Unauthorized construction by the owner of the third floor on the roof adding a dwelling unit & converting it to 4th floor.
- iii. Construction on projection by few owners of 1st floor and owners of floors above first floor as in case of Flat No. 125.
- iv. Encroachment in the open service area existing between 2 flats and misuse of the same.

Till date no status report has been submitted by the grid officer on complaint made by Mr. D.R. Sori which has been forwarded by SDMC on 30.11.2018 (STF No. 2081-STF)

- b) The team also visited sector A, Vasant Kunj on complaint received in STF regarding encroachment on road by the owner of the ground floor, flat no. 1001. Sh. H.M. Meena A.E. (Main) and Sh. Sandeep JE(M) from SDMC were also accompanied the team. The photographs and videos taken during the visit will be presented. The observation during the site visit are as follows:
 - i. Regarding flat no. 1001, sector-A: Demolition action has been carried out. Bamboo fencing was removed by SDMC but the existing gates were not removed. Subsequently AE, M-4, SDMC was suggested to remove the gates and make the area open to public. AE(M)IV has submitted the photograph showing the removal of gates and Bamboo fencing.
 - ii. The area was also visited where it was observed that SDMC has taken action on removal of encroachment. Few flats where there are encroachment made by ground floor owners were shown to the concerned officer and suggested to remove the encroachment and submit the action taken report the report has been received from AE(M)IV on 12.03.2019 with photographs showing the demolition action has been carried out.

It is suggested that regular monitoring of encroachment and removal of the same from the road by the ground floor owners needs to be ensured by the concerned Grid officers.

c) The STF team also observed encroachment on the main Mehrauli Mahipalpur road in the form of temporary shops and car repairing shops in the R/W. On other side of road, the space of R/W is being utilized for unauthorized parking by Atul Motors. A presentation with video and photographs will be made before STF the road falls in the jurisdiction of PWD.
